145. Crash Description/Narrative

Vehicle #1 was traveling west bound on State Hwy 88 approaching Truman Drive. Bicyclist #1 was also traveling west bound in the shoulder of State Hwy 88, approaching Truman Drive.

Driver #1 stated he was attempting to make the right hand turn onto Truman Drive when Bicyclist #1 struck the right front of his vehicle. Driver #1 stated they did not see the bicyclist due to his dark clothing, no lights, and no reflectors in a poorly lit area. Passenger #1 also stated she did not see bicyclist #1 as they were approaching their turn.

Bicyclist #1 stated he was riding down the shoulder when Vehicle #1 made a right turn in front of him and he could not stop in time. Bicyclist #1 fell off his bike and suffered a very minor laceration to his knee but refused any sort of medical treatment. While speaking with Bicyclist #1, I confirmed the dark clothing, no lights and no reflectors at night that Driver #1 stated.

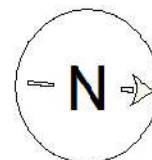
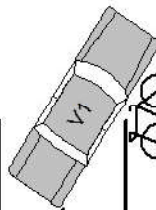
