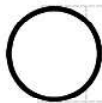

145. Crash Description/Narrative

On 11/20/2017 at approximately 1710 hours, I responded to the area of Route 70 and Olden Street in reference to a two car motor vehicle crash. Both Vehicles were on Olden Street south awaiting the traffic signal when Vehicle #1 struck vehicle #2 from behind.

Driver of Vehicle #1 stated the driver of Vehicle #2 "removed her foot from the brake and rolled back into me."

Driver of Vehicle #2 stated vehicle #1 struck her from behind.

While on scene I checked the area where the motor vehicle crash and did not observe a "hill" that would cause Vehicle #2 to roll backward. It should also be noted Vehicle #2 had an automatic transmission. Due to on scene investigation I found Vehicle #1 to be the at fault vehicle.

No injuries were reported on scene.

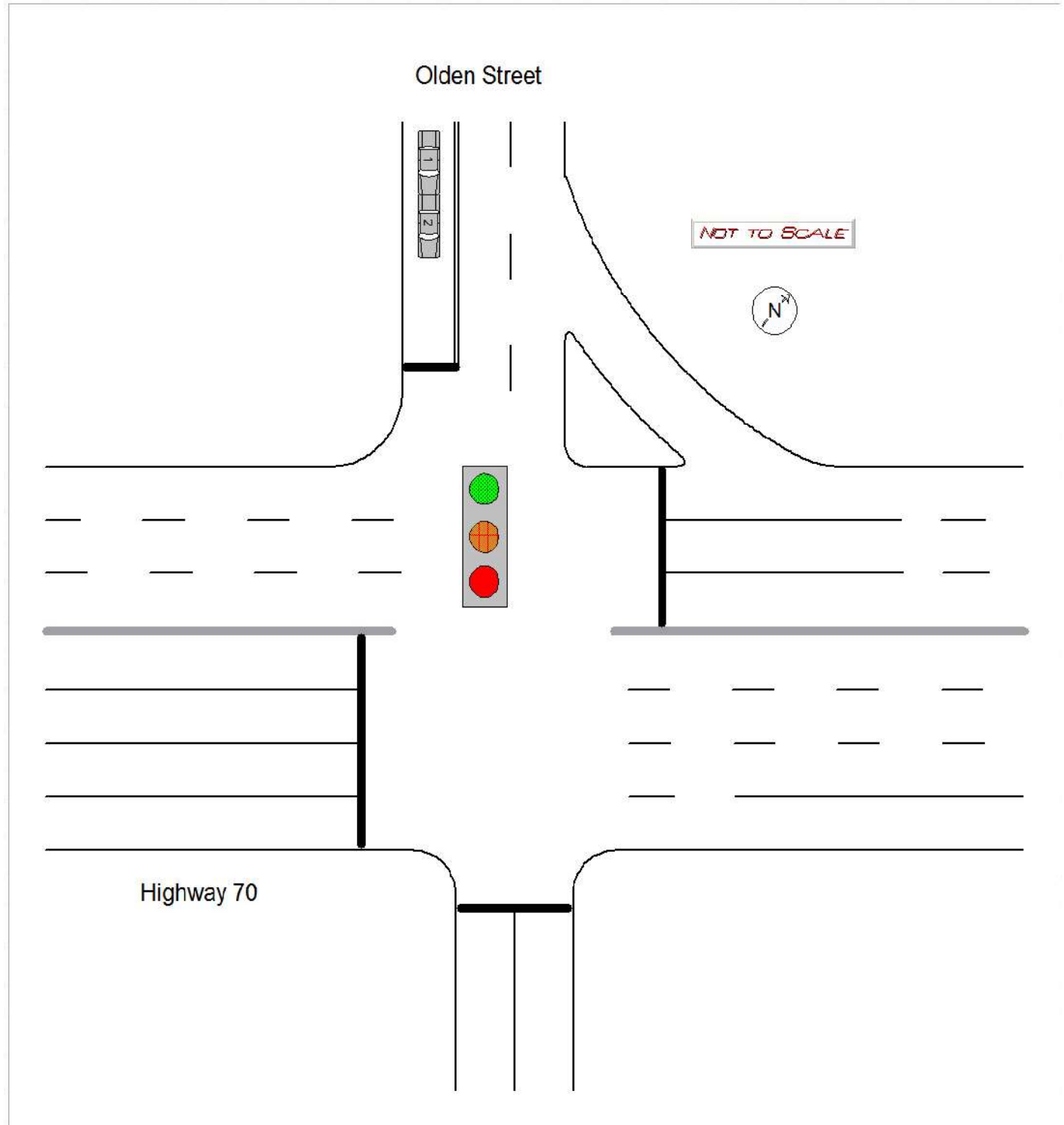
