145. Crash Description/Narrative

Vehicle #1 was traveling West in the left Lane of Route 88 approaching the intersection at Route 70. Vehicle #2 was slowing down in traffic directly in front of Vehicle #1. The front end of Vehicle #1 collided with the rear end of Vehicle #2, pushing Vehicle #2 forward a short distance and then up onto the curbed median where it came to rest.

Driver #1 advised that he was driving West in the left lane when he closed his eyes and nodded off briefly before colliding with the rear of Vehicle #2. Driver #1 explained that he works seven days a week and was extremely tired. In speaking with Driver #1, he did not appear to be under the influence of any drugs or alcohol.

Driver #2 advised that he was slowing down in traffic to stop at the red light when he was suddenly struck in the rear by Vehicle #1. Driver #2 stated he was then pushed forward several feet by Vehicle #1 before swerving to his left and up onto the median to avoid colliding with the vehicle in front of him.

Based upon my observations, and statements made by both drivers, I find Driver #1 at fault for careless driving.

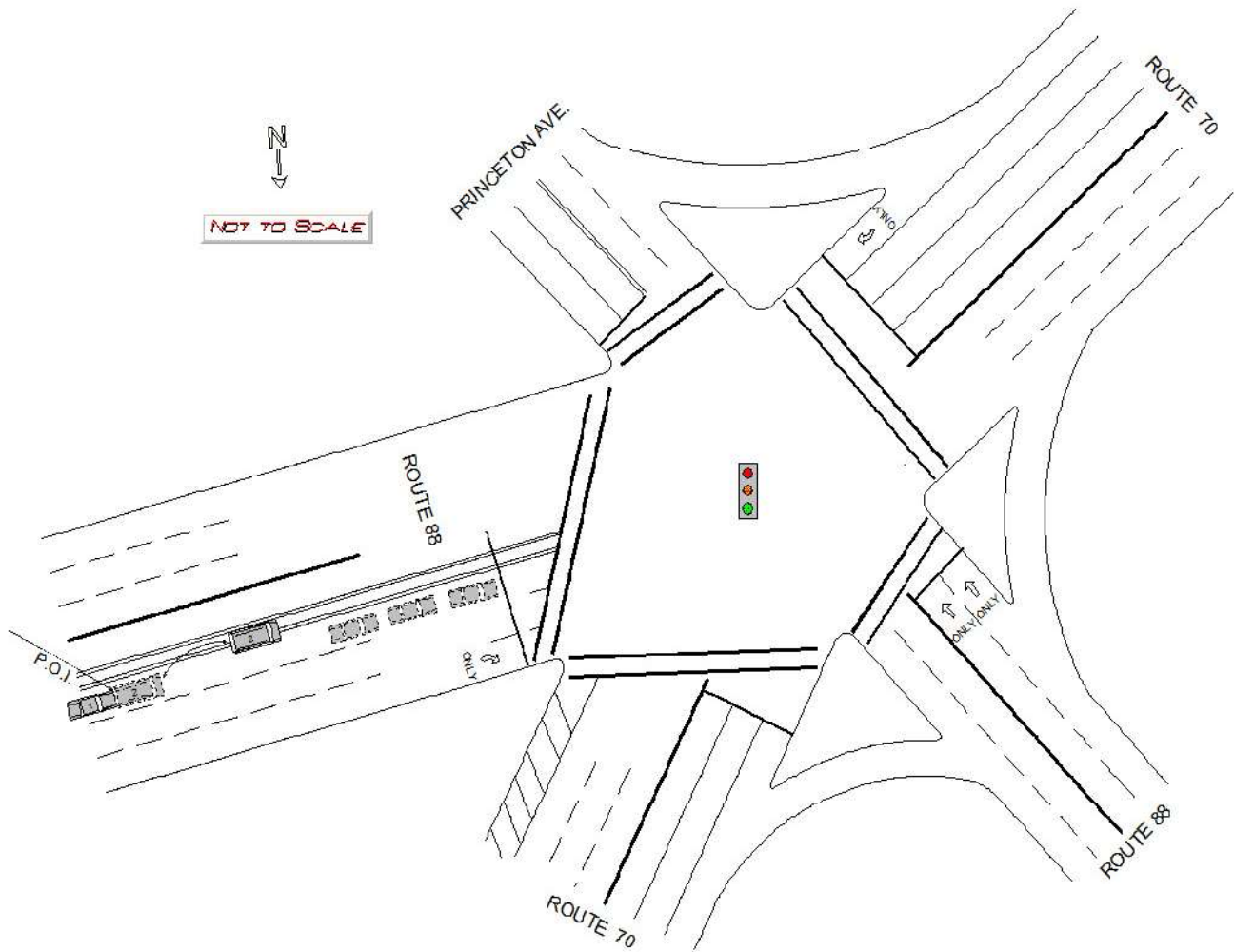
