145. Crash Description/Narrative

Vehicle 1 was backing out of the parking stall in the lot of 2138 Rt. 88. Vehicle 2 was traveling in the lot and preparing to park in a parking stall. The crash occurred when vehicle 1 struck vehicle 2 as it was backing. No injuries were reported. On scene I observed minor damage to the rear of vehicle 1 and the left middle of vehicle 2.

The driver of vehicle 1 stated he was backing and did not see vehicle 2. The driver of vehicle 2 stated she was driving in the lot when her vehicle was struck.

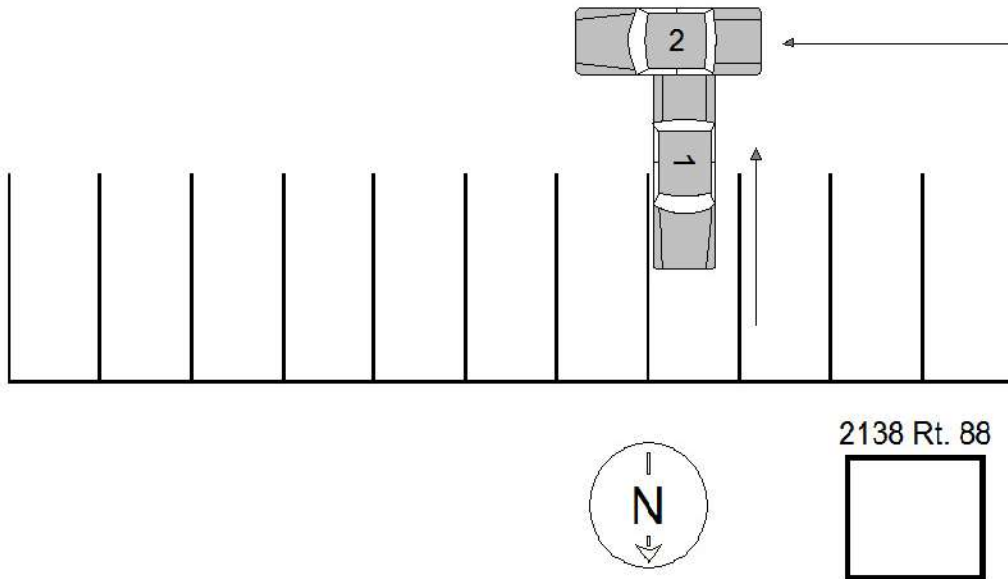
