145. Crash Description/Narrative

On scene investigation revealed that vehicle 1 and vehicle 2 were traveling northbound on Jack Martin Blvd.

Vehicle 2 was waiting to execute a left hand turn into 425 Jack Martin Blvd (Ocean Medical Center). Vehicle 1 collided with the rear of vehicle 2. The drivers provided the following statements:

Driver 1 stated she was traveling north along Jack Martin Blvd. Driver 1 stated that vehicle 2 had stopped suddenly near the entrance of OMC. Driver 2 stated she was unable to stop in enough time and collided with vehicle 2. Driver 1 did not report any injuries on scene, nor did any passengers. Vehicle 1 had heavy front end damage with front air bag deployment. Vehicle 1 was towed by D&L Towing.

Driver 2 stated she was traveling north along Jack Martin Blvd when she activated her left turn signal and came to a complete stop waiting to turn into OMC. Driver stated she was then struck by vehicle 1 from behind. Driver 2 did not report injuries on scene, however the front passenger had a complaint of chest pain and a laceration on her right hand. BTEMS #535 responded to the scene and transported the front passenger to OMC for further evaluation. Vehicle 2 had heavy rear end damage. Vehicle 2 was towed by Glen's Towing.

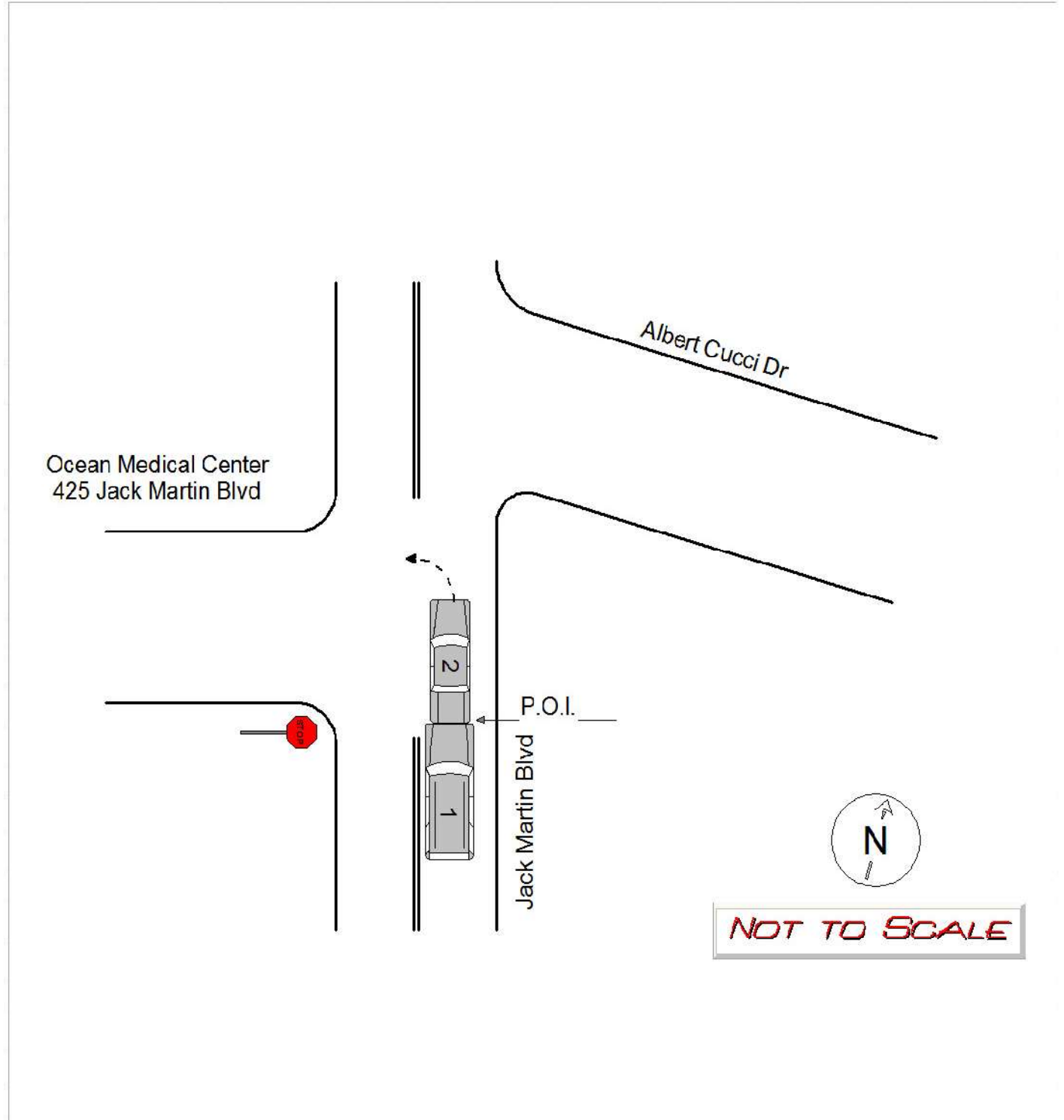
