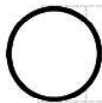

145. Crash Description/Narrative

Vehicle #1 was traveling east on Rt 70 in the center lane directly next to vehicle #2 which was traveling east in the right lane.

Driver of vehicle #1 stated she was in the center lane (Lane 3) and Driver #2 came into her lane causing damage to the right side of her vehicle. Driver #1 came to a stop in the Walmart Parking lot. She stated she did not feel it was safe to stop on Rt. 70 after the crash.

Driver #2 stated she was in the right lane and vehicle #1 came into her lane. She stated she is positive she maintained her lane of travel and vehicle #1 caused the crash. She stated vehicle #1 attempted to leave the scene of the accident and she followed Driver #1 until it came to a stop in the Walmart parking lot.

My investigation determined that one of the vehicles failed to maintain their lane of travel. I was unable to determine which party was at fault due to conflicting statements from each driver and the lack of any witnesses.

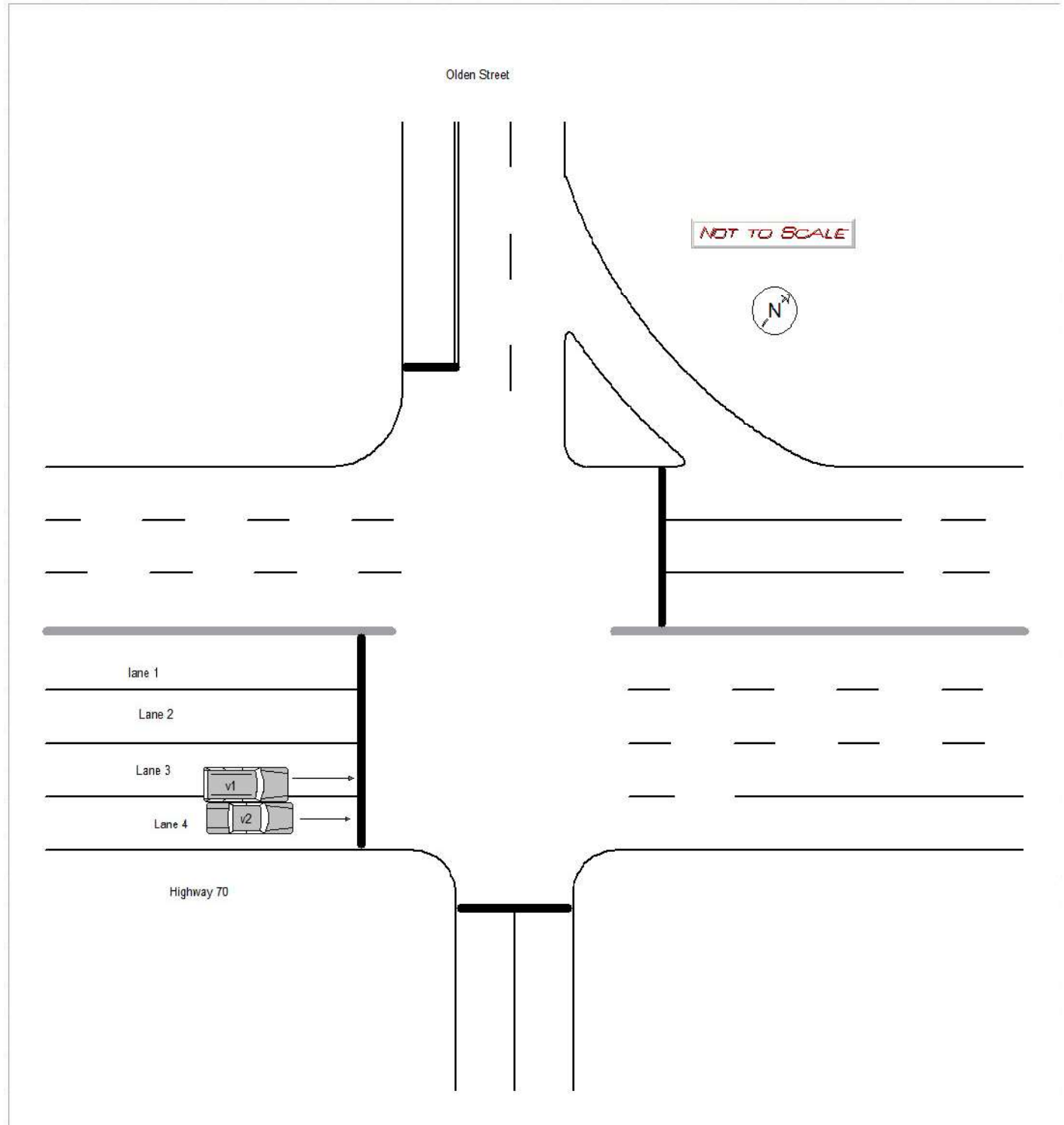
