145. Crash Description/Narrative

On scene I observed vehicle #1 and vehicle #2 in the far right lane on Van Zile Road. I approached both vehicles and spoke to the drivers who stated both their vehicles were operational and could be moved out of traffic. Once they moved the vehicles, Driver #2 explained she had neck pain. Brick EMS #533 arrived on location to care for driver #2. Driver #1 explained she was not injured and stated the following:

She might have been following Vehicle #2 too closely. As they approached the stop light at Route 88 she rear ended vehicle #2. After speaking to Driver #1, I spoke to Driver #2 who stated the following:

When driver #2 got to the traffic light at Route 88 and Van Zile Road vehicle #1, rear ended her.

Both vehicles had minor damage. I observed a small scratch on the rear of vehicle #2 and a small scratch on the front of vehicle #1. Driver #2 was transported to Ocean Medical hospital for a neck injury. Driver #1 was issued a summons: 39:4-97 Careless (E18 000524)

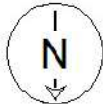

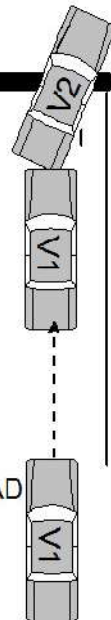
