Vehicle 2 stopped for the red traffic light, in the right lane of Van Zile Road southbound, approaching Route

70. Vehicle 1 traveling straight ahead, directly behind Vehicle 1.

Driver 2 stated he was stopped, waiting for the traffic light to change when he was struck from behind by

Vehicle 1.

Driver 1 stated he could see Vehicle 2 stopped in front of him and as he approached he began to brake.

Driver 1 stated he was attempting to stop when he struck the rear of Vehicle 2. Driver 1 advised he misjudged

his braking and the brakes of his vehicle.

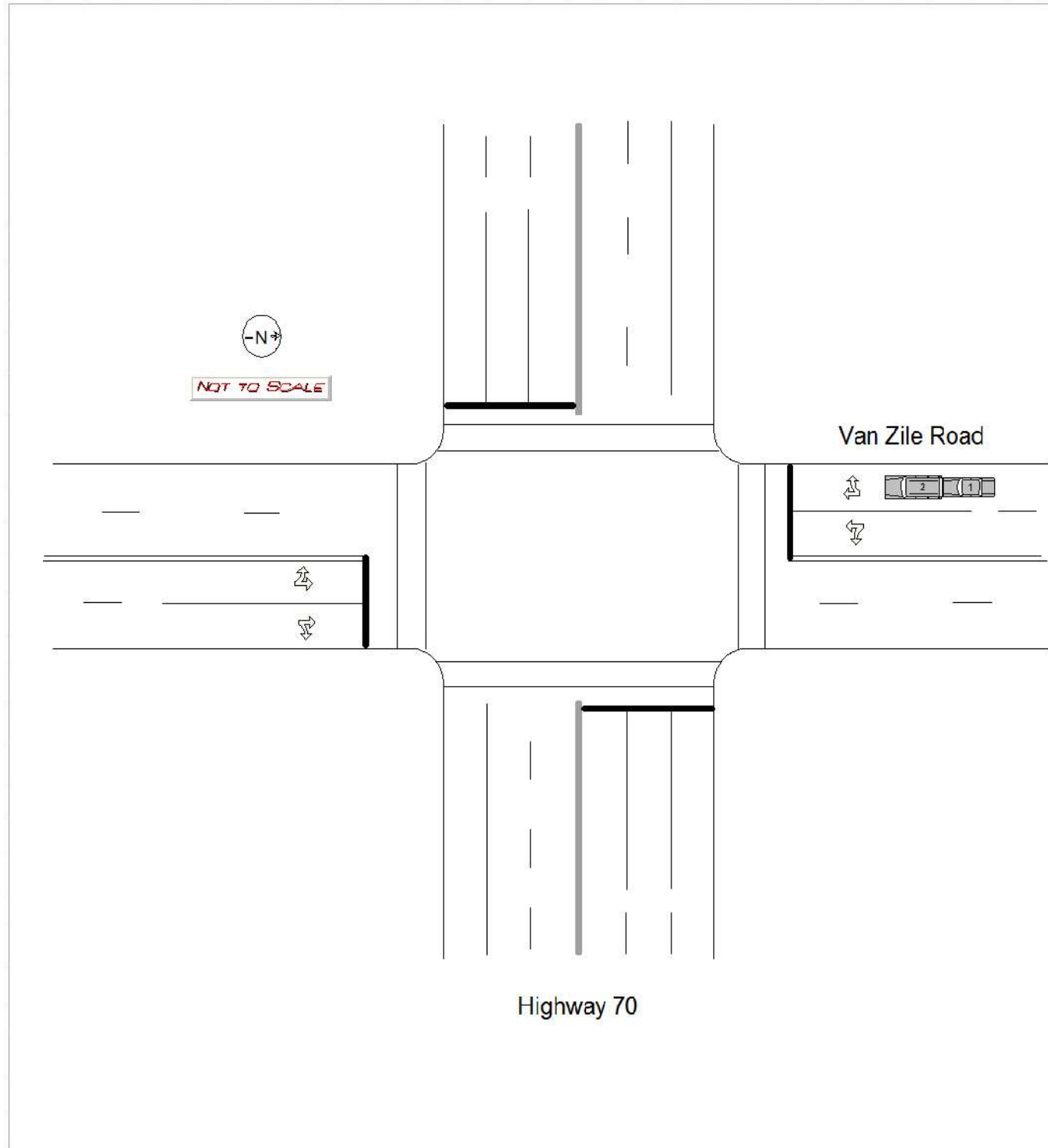
