145. Crash Description/Narrative

Vehicle #1 was backing out of a marked parking space in row #6 in the Walmart parking lot. Vehicle #2 was traveling north in the lane between row 5 and 6, in the Walmart parking lot.

The driver of Vehicle #2 stopped her vehicle as she waited for a parking space to open. The driver of Vehicle #1 failed to observe Vehicle #2, directly behind his vehicle, and backed into Vehicle #2, at a slow speed. Both vehicles had minor damage and no injuries were reported.

The driver of Vehicle #1 admitted that he did not see Vehicle #2 and that he backed up directly into the vehicle.

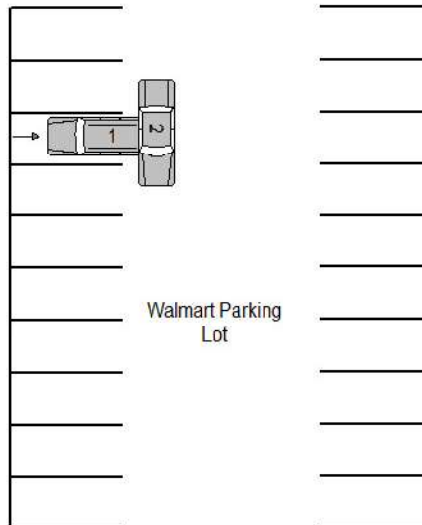
144 Crash Diagram (NOT TO SCALE)
