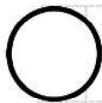

145. Crash Description/Narrative

Vehicle 01 was traveling west on Rt 88 when it struck Vehicle 02 in the rear approximately 50 feet west of Coolidge Dr.

Driver of Vehicle 01 stated he was traveling west on Rt 88 and did not observe Vehicle 02 stopped in front of him. Driver of Vehicle 01 further stated he could not stop in time striking Vehicle 02 in the rear.

Driver of Vehicle 02 stated she was traveling west on Rt 88 when she had stopped behind a vehicle attempting a left turn into the 711 store by Coolidge Dr. when she was struck in the rear by Vehicle 01.

Both vehicles moved prior to Police arrival.

Driver of Vehicle 01 was issued a summons for 39:4-97 #E17 007555.

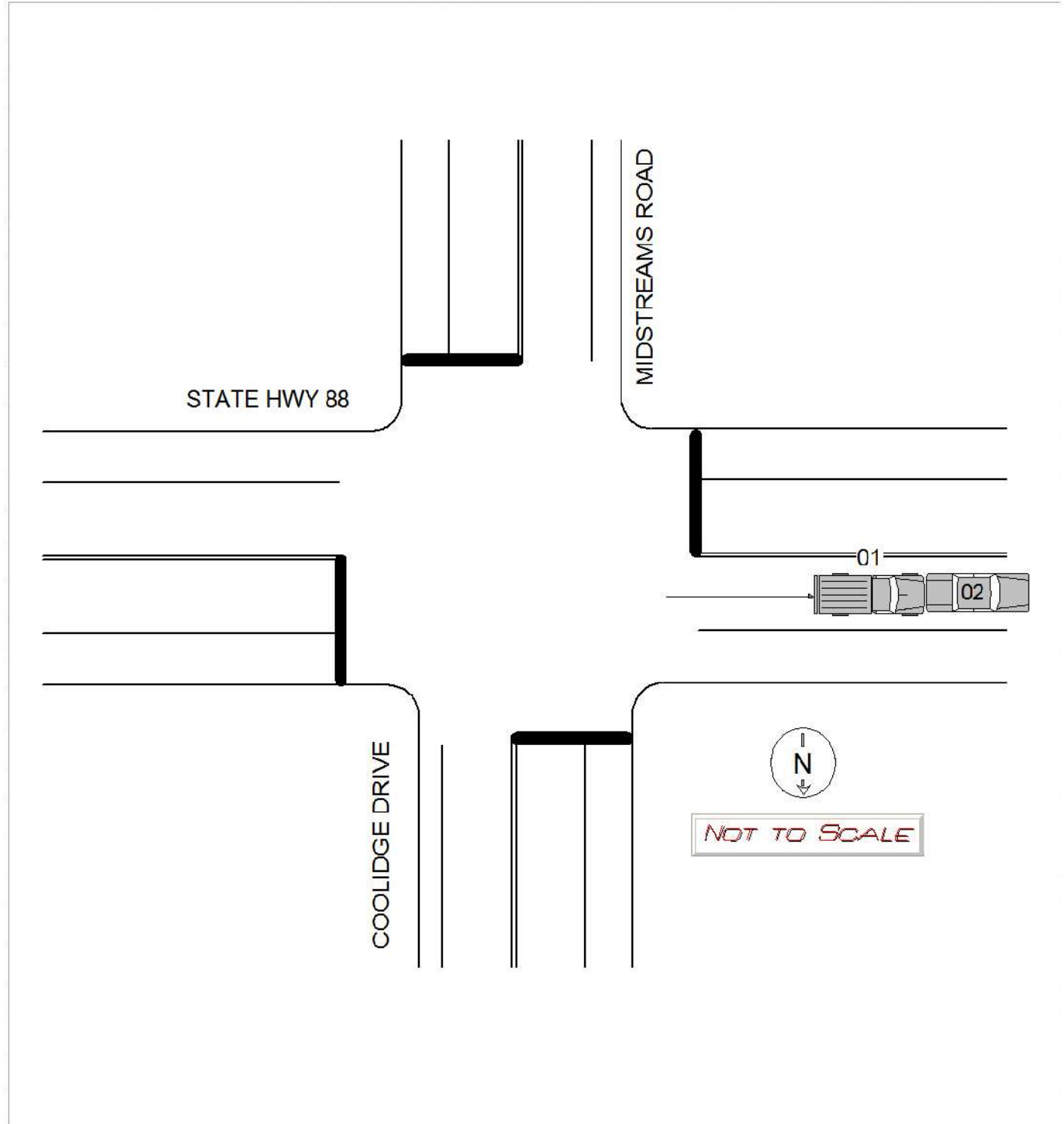
