145. Crash Description/Narrative

Vehicle 1 was traveling westbound on Route 88 approaching the area of John St.

Vehicle 2 was traveling eastbound on Route 88 slowing down to make a left turn into the Speedway gas station.

Vehicle 1 veered left crossing over the center dash line and impacted Vehicle 2.

Driver of Vehicle 1 was transported to Jersey Shore University Medical Center, Neptune NJ with a head injury. It was later determined that Driver 1 also suffered a fractured vertebrae in her neck as a result of the crash.

Driver of Vehicle 1 was not wearing her seatbelt at the time of the crash.

Driver of Vehicle 2 complained of head and back pain; however refused medical treatment on scene. The Driver of Vehicle 2 responded on her own to Ocean Medical Center, Brick NJ following the crash.

Driver of Vehicle 2 stated that she was slowing down to make a left turn into the gas station when Vehicle 1 just crossed over into her lane and struck her vehicle.

Driver of Vehicle 1 who was conscious and alert at the hospital, could not recall the events of the crash.

Based on my investigation, the actions of Driver 1 are the cause of the crash. For unknown reasons the Driver of Vehicle 1 failed to maintain her lane crossing over the center line into oncoming traffic.

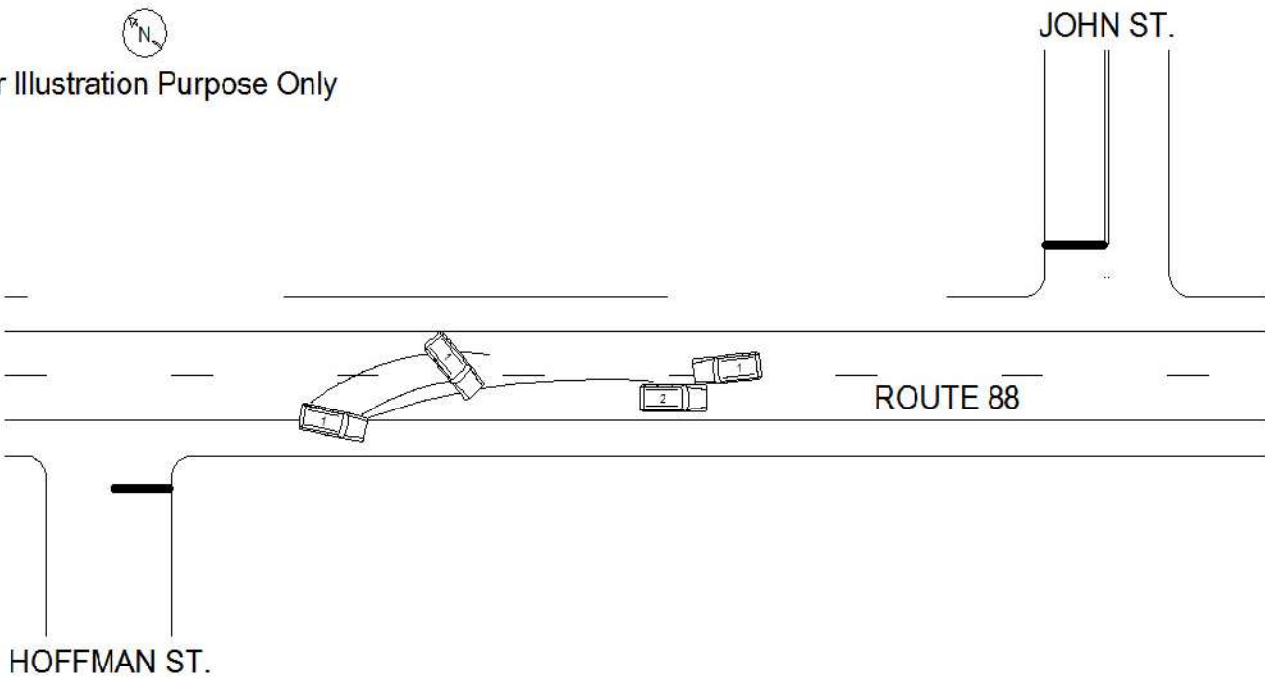
