were damaged.

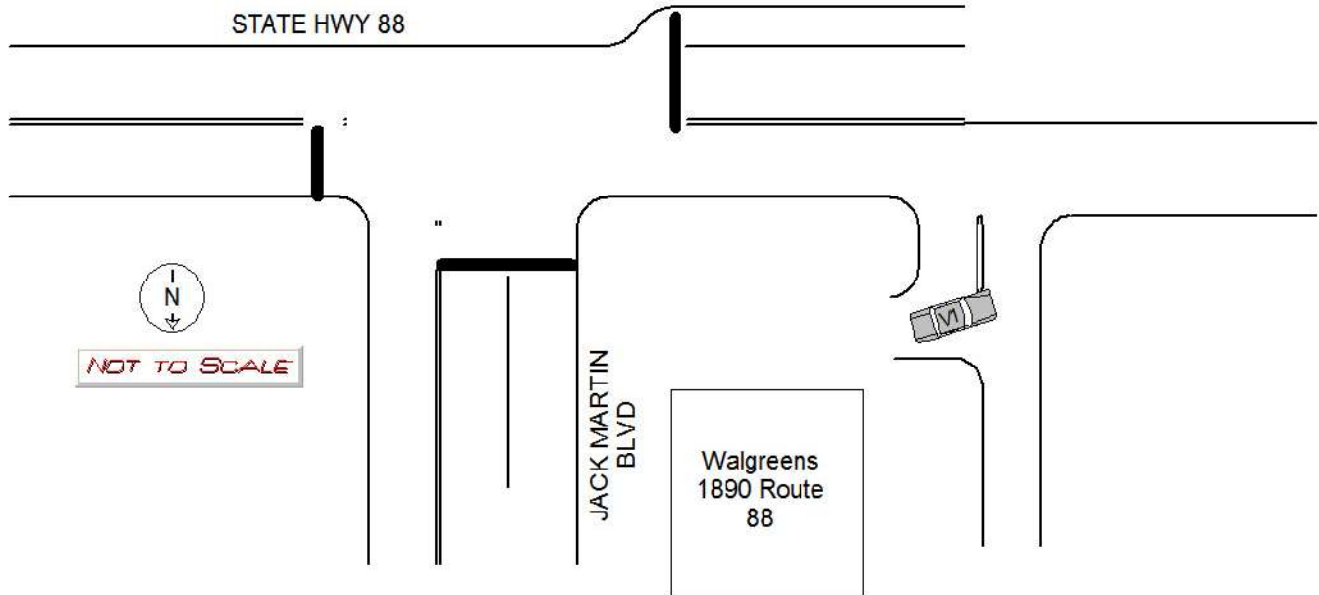
I observed the rim and observed the rim to be broke causing the tire to deflate.
