145. Crash Description/Narrative

Vehicle #1 was traveling east bound on State Highway 88 approaching Brentwood Avenue. Vehicle #2 was traveling directly in front of Vehicle #1.

Driver #2 stated he was slowing down to make a right hand turn into the entrance of Olympic Gardens (1451 State Highway 88). Driver #2 stated he put his turn signal on as he approached the entrance and began to turn when Vehicle #1 struck the right side of his vehicle from the shoulder.

Driver #1 stated she was driving behind Vehicle #2 and saw the turn signal that she thought was a left turn signal so as Vehicle #2 began to slow down, she moved towards the shoulder to go around and when he made a right hand turn the vehicles collided.

Due to my observations on scene and driver statements, I determined Vehicle #1 to be at fault for the crash.

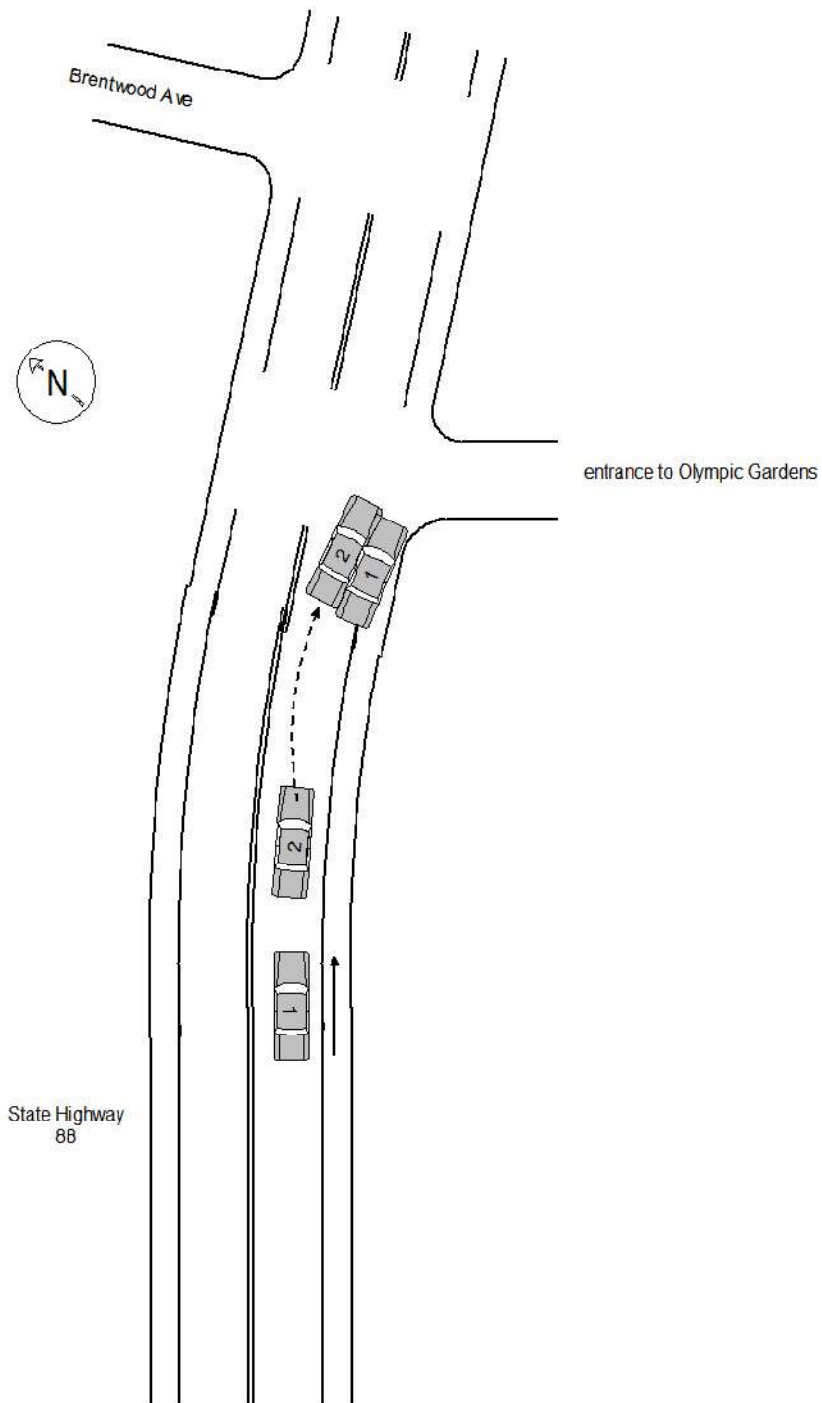
