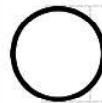

145. Crash Description/Narrative

Investigation reveals vehicle 1 and vehicle 2 were stopped at the red traffic signal at the intersection of
 Rt.70 & Jack Martin Blvd. Vehicle 1 was in the marked lane where the vehicle must make a left. Vehicle 2 was in
 the center lane where you can choose to make a left or proceed straight.

Driver of vehicle 1 states when the light turned green, he began to turn left from Jack Martin onto Rt. 70.
 Vehicle 2 crossed onto his lane and both vehicles collided.

Driver of vehicle 2 states when the light turned green, she began to turn left from Jack Martin Blvd. onto
 Rt.70. Vehicle 1 began to turn left then abruptly continued straight in the mandatory left turn lane. Vehicle 1
 struck her vehicle.

Witness states she was directly behind vehicle 2 at the traffic light. As the light turned green, vehicle 1
 & vehicle 2 began to turn left. Vehicle 1 put his right blinker on in the mandatory left turn lane. Rather than
 complete his left turn, vehicle 1 went straight and struck vehicle 2.

No injuries were reported on scene.

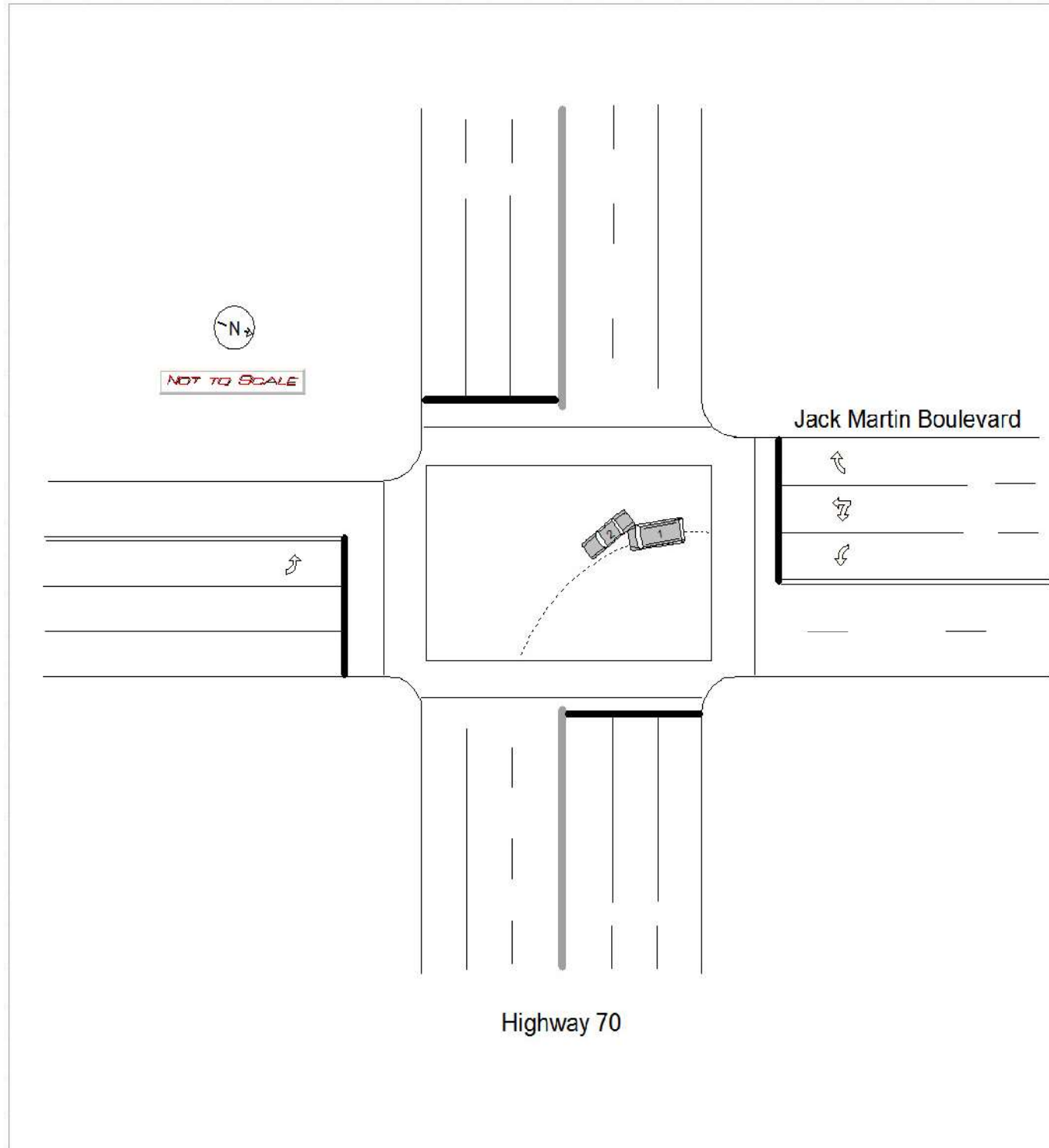
