145. Crash Description/Narrative

On 10/13/2017 at 1058hrs vehicles were stopped at the red traffic signal on Midstreams Rd at the Rt 88 intersection. Vehicle#1 struck the rear of vehicle#2.

Driver of vehicle#1 stated she was behind vehicle#2. She stated that she lifted her foot off the brake and rolled into vehicle#2.

Driver of vehicle#2 stated he was on Midstreams Rd stopped at the red traffic signal at Rt 88 when he was struck from behind by vehicle#1.

Vehicle#1- minor damage to the hood and front bumper.

Vehicle#2- damage to the passenger side rear bumper. The bumper appears to have been pushed slightly into the body.

No injuries observed or reported.

Driver of vehicle#1 was issued a Careless Driving 39:4-97 summons- E17007046.

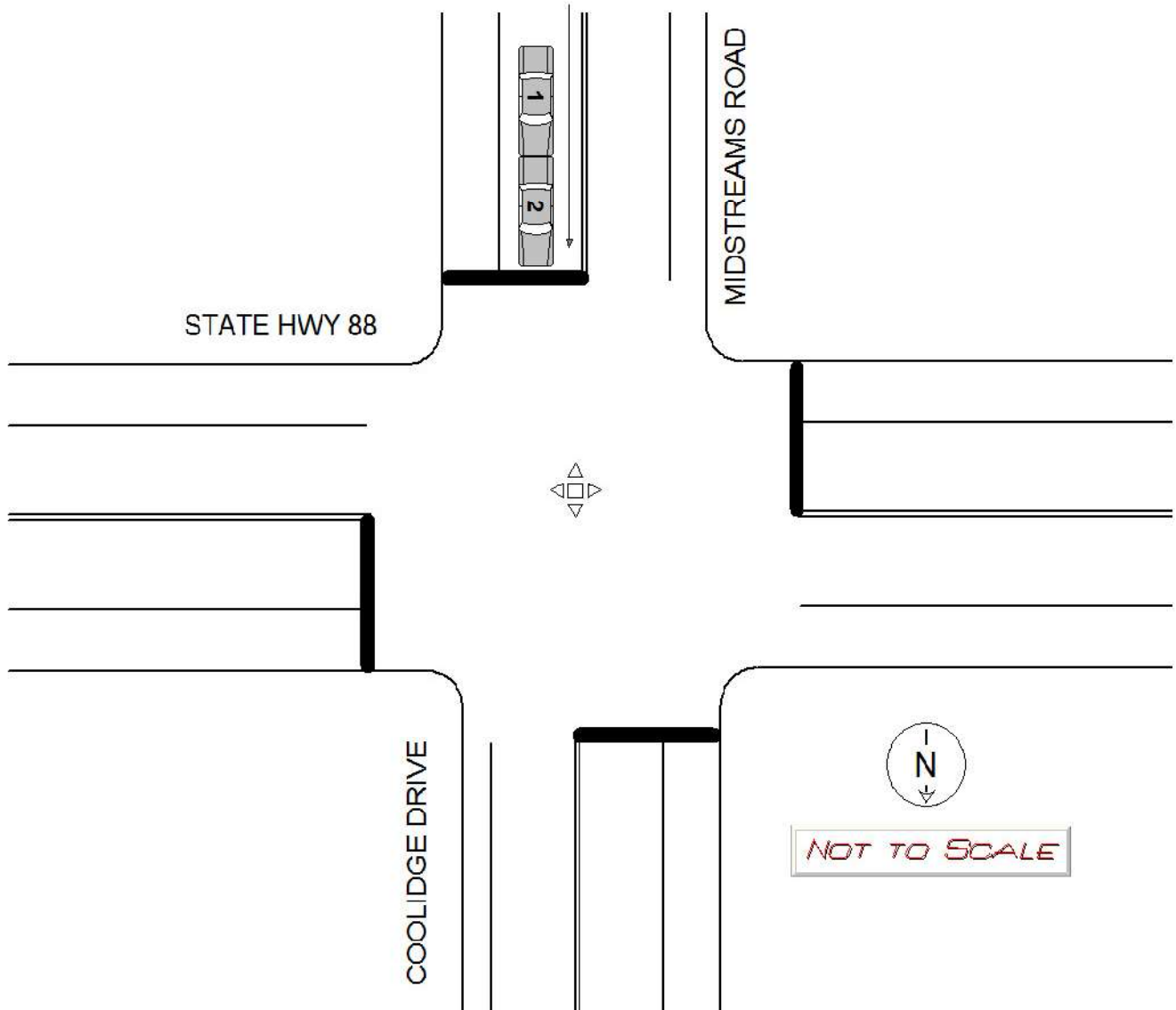
