145. Crash Description/Narrative

Both Vehicles 1 and 2 were traveling west on Route 88 in the area of Jack Martin Blvd. Vehicle 2 slowed down to make a left turn into the parking lot of 1893 Route 88. Vehicle 1 did not see Vehicle 2 slow down in traffic due to the sun glare and struck the rear of Vehicle 2.

Driver of Vehicle 1 stated she was traveling west on Route 88 in the area of Jack Martin Blvd. Driver of Vehicle 1 stated due to the sun glare she did not see Vehicle 2 slowing in traffic to make a left turn into the parking lot of 1893 Route 88. Driver of Vehicle 1 stated she was unable to get around Vehicle 2 and struck the rear of Vehicle 2 with the front of her vehicle.

Driver of Vehicle 2 stated he was traveling west on Route 88 in the area of Jack Martin when he activated his left turn signal and began to slow in traffic to make a left turn into the parking lot of 1893 Route 88. Driver of Vehicle 2 stated the rear of his vehicle was struck by the front of Vehicle 1 while he was slowing in traffic.

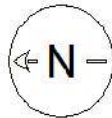

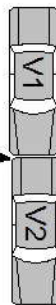
