145. Crash Description/Narrative

Vehicle 01 was traveling east on Rt. 88. Vehicle 02 was traveling west on Rt. 88. Vehicle 01 veered into the westbound lane and attempted to make a left turn into Ocean Medical Center in front of vehicle 02 causing vehicle 02 to hit vehicle 01.

Vehicle 01 driver stated that she attempted to make a left turn into Ocean Medical Center an was struck by vehicle 02. Vehicle 02 driver stated she was traveling west on Rt. 88 when vehicle 01 came into her lane of travel head on and then made a left turn into the exit side of the Ocean Medical Center entrance/exit causing vehicle 02 to hit vehicle 01.

Vehicle 02 driver had a complaint of pain to her right knee. Brick Township Police EMS responded, assessed the injury and transported vehicle 02 driver to Ocean Medical Center for treatment. Vehicle 01 driver and passengers did not have any complaints of pain or injury on scene. Upon completion of my investigation I found vehicle 01 to be at fault.

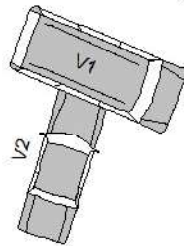

144 Crash Diagram (NOT TO SCALE)

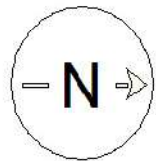
