145. Crash Description/Narrative

Driver 1 stated she did not see any vehicles behind her as she attempted to back out of her parking space. She advised her vehicle collided with vehicle 2 after it came around the bend in the parking lot.

Driver 2 stated she was driving in the parking lot and as she rounded the bend, she was struck by vehicle 1 which was backing.

While on scene the high volume of both parked and moving vehicles within the parking lot may have been a possible contributing factor to each driver's inattention.

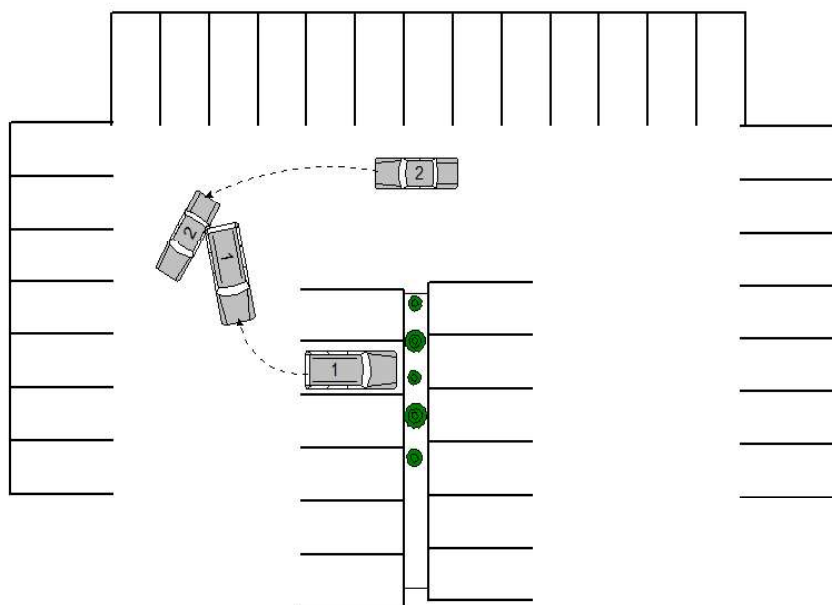
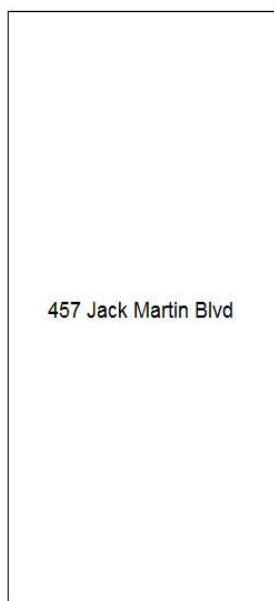
