145. Crash Description/Narrative

Vehicle 01 and Vehicle 02 were backing from opposite parking spaces when they collided in the middle of the parking lot of 1890 Rt 88.

Driver of Vehicle 01 stated she had backed out of her parking space first when vehicle 02 started to back out from the opposite side and struck Vehicle 01.

Driver of Vehicle 02 stated she was backing out of the first parking on the north side by the front door when Vehicles 01 and 02 struck each other. Driver of Vehicle 02 stated she did not see Vehicle 01 and that they must have backed out of their parking spaces at the same time.

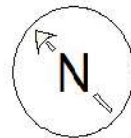

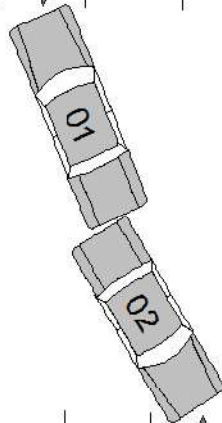
144 Crash Diagram (NOT TO SCALE)
