145. Crash Description/Narrative

Vehicle 1 was traveling West on Rt. 88. Vehicle 2 was traveling East on Rt. 88. Vehicle 1 made a left turn into a driveway for Oxford Plaza (1715 Rt. 88). Vehicle 1 failed to yield right of way to vehicle 2 and vehicle 2 struck vehicle 1. The impact caused vehicle 1 to spin about 180 degrees clockwise, impact a curb and a concrete base to an overhead light.

Driver 1 stated that he had exited the Home Depot parking lot, making a right turn onto Rt. 88 West. Driver 1 then made a left turn into Oxford Plaza. Driver 1 stated that he did not see vehicle 2 prior to turning.

Driver 2 stated that she was traveling straight ahead and vehicle 1 abruptly turned directly in front of her.

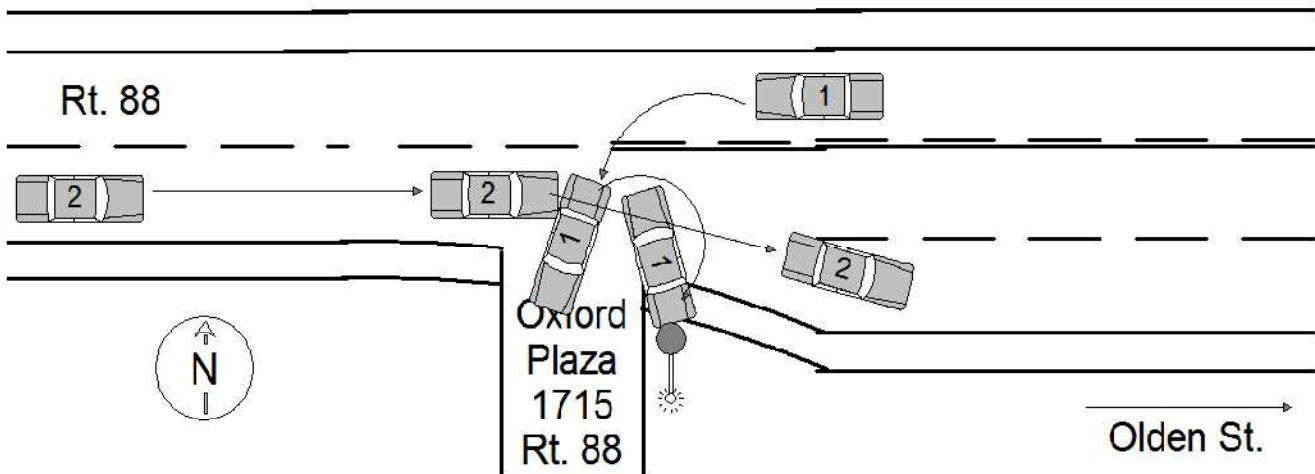
