145. Crash Description/Narrative

Vehicle 1 was traveling eastbound on Rt 70 in the rightmost lane. Vehicle 1 then began to utilize the entrance to The Shops at Brick, 141 Van Zile Rd. Vehicle 1 lost control running off the road, striking a curb, and coming to final rest when the vehicle collided with a structural pole for a sign.

Driver 1 stated he was traveling eastbound on Rt 70. Driver 1 stated the light at Rt 70 and Van Zile had turned red. As a result, Driver 1 decided to enter The Shops at Brick Plaza. Driver 1 stated he utilized his brakes, however the vehicle did not stop. Driver 1 further stated that was when he ran off the road and struck the sign.

On scene, I observed skid marks approximately 47 yards in length leading from Rt 70 to the cars final resting point. Driver 1 was issued a summons for Careless Driving (39:4-97) on summons E17 6669.

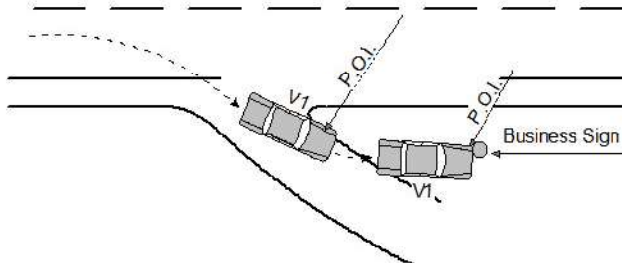
