145. Crash Description/Narrative

Vehicle #1 was traveling southbound Jack Martin Blvd. in the area of Route 70. Vehicle #2 was directly in front of vehicle #1 stopped for the red traffic signal. The traffic signal turned green at which time vehicle #1 collided with the rear end of vehicle #2. Driver #2 stated the traffic signal turned green and while she was waiting for the vehicles in front of her to move forward, vehicle #2 collided with the rear end of her vehicle. Driver #1 stated when she realized vehicle #2 was still stopped she attempted to stop and her foot slipped off the brake pedal causing her to continue to move forward colliding with vehicle #2. Consequently, the investigation was concluded with driver #1 at fault.

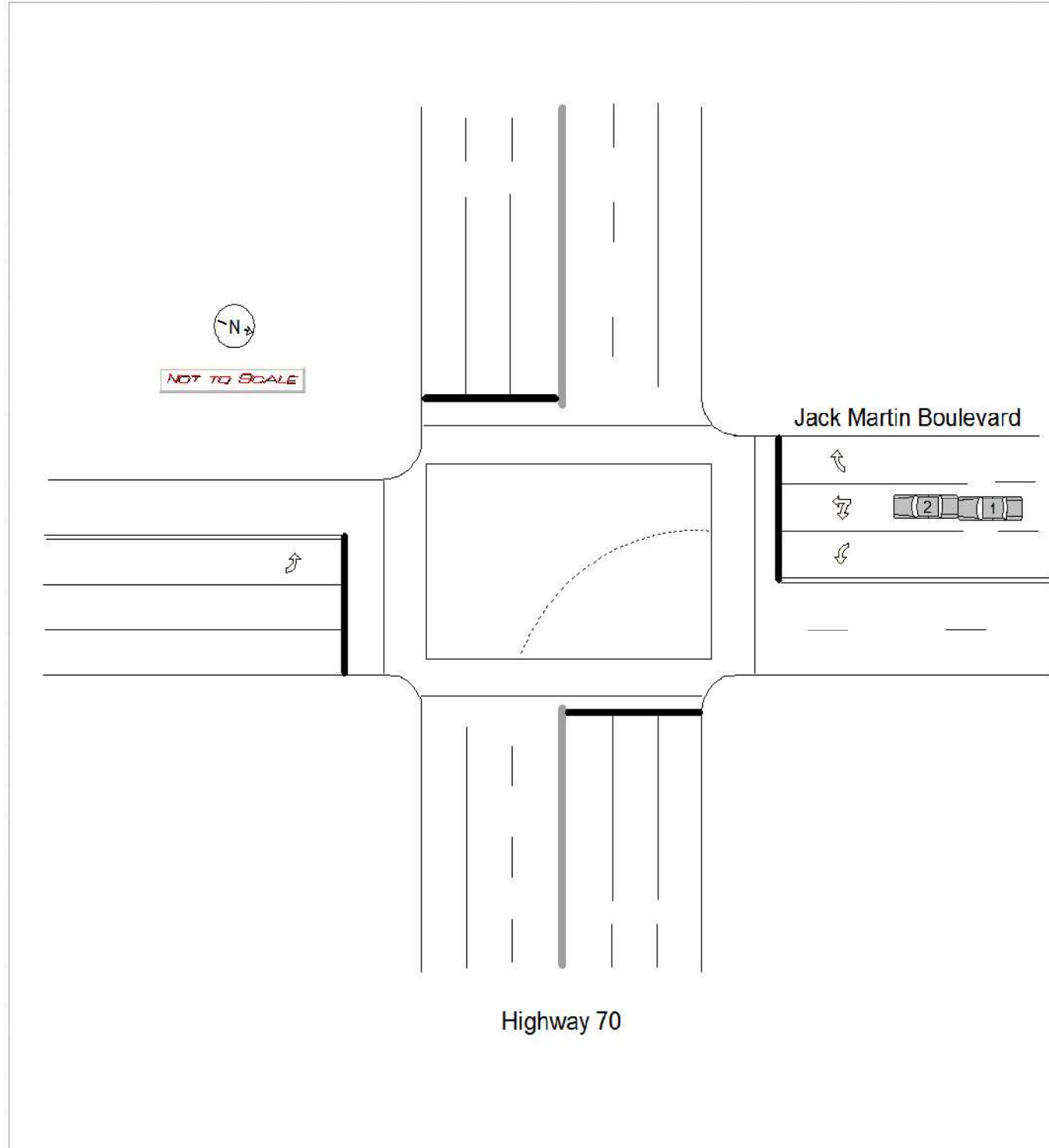
