145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 2 traveled south on Jack Martin Boulevard in the area

the intersection with Quadara Boulevard and vehicle 1 traveled directly behind vehicle 2. As vehicle 2 approached

the intersection, vehicle 2 drove on the shoulder of the roadway to pass a vehicle on the right and vehicle 1

followed. While both vehicles traveled south on the shoulder, the front of vehicle 1 struck the rear of vehicle

2.

I spoke to driver 1 on scene and she stated the following:

Driver 1 traveled south on Jack Martin Boulevard directly behind vehicle 2. As both vehicles approached the

intersection with Quadara Boulevard, vehicle 2 drove onto the shoulder of the roadway to pass a vehicle that was

stopped to make a left turn onto Quadara Boulevard. Driver 1 followed vehicle 2 onto the shoulder and as she was

behind vehicle 2, the vehicle came to a sudden stop. Driver 1 was unable to stop her vehicle in time to avoid

collision, and the front driver side of her vehicle struck the rear passenger side of vehicle 2.

I spoke to driver 2 on scene and he stated the following:

145 Crash Description

Driver 2 traveled south on Jack Martin Boulevard near the intersection with Quadara Boulevard. Driver 2 saw a vehicle stopped in traffic with its left blinker on. Driver 2 drove onto the shoulder of the roadway to pass the vehicle stopped in traffic. As he passed the vehicle, he noticed there were vehicles backed up from the intersection of Route 70 and Jack Martin Boulevard. Driver 2 then stopped his vehicle so he could get back into the correct lane of travel. While stopped on the shoulder of the roadway, the rear of his vehicle was struck by the front of vehicle 1.

Driver 1 and driver 2 were both at fault for the accident and I issued both drivers a summons for Careless Driving.

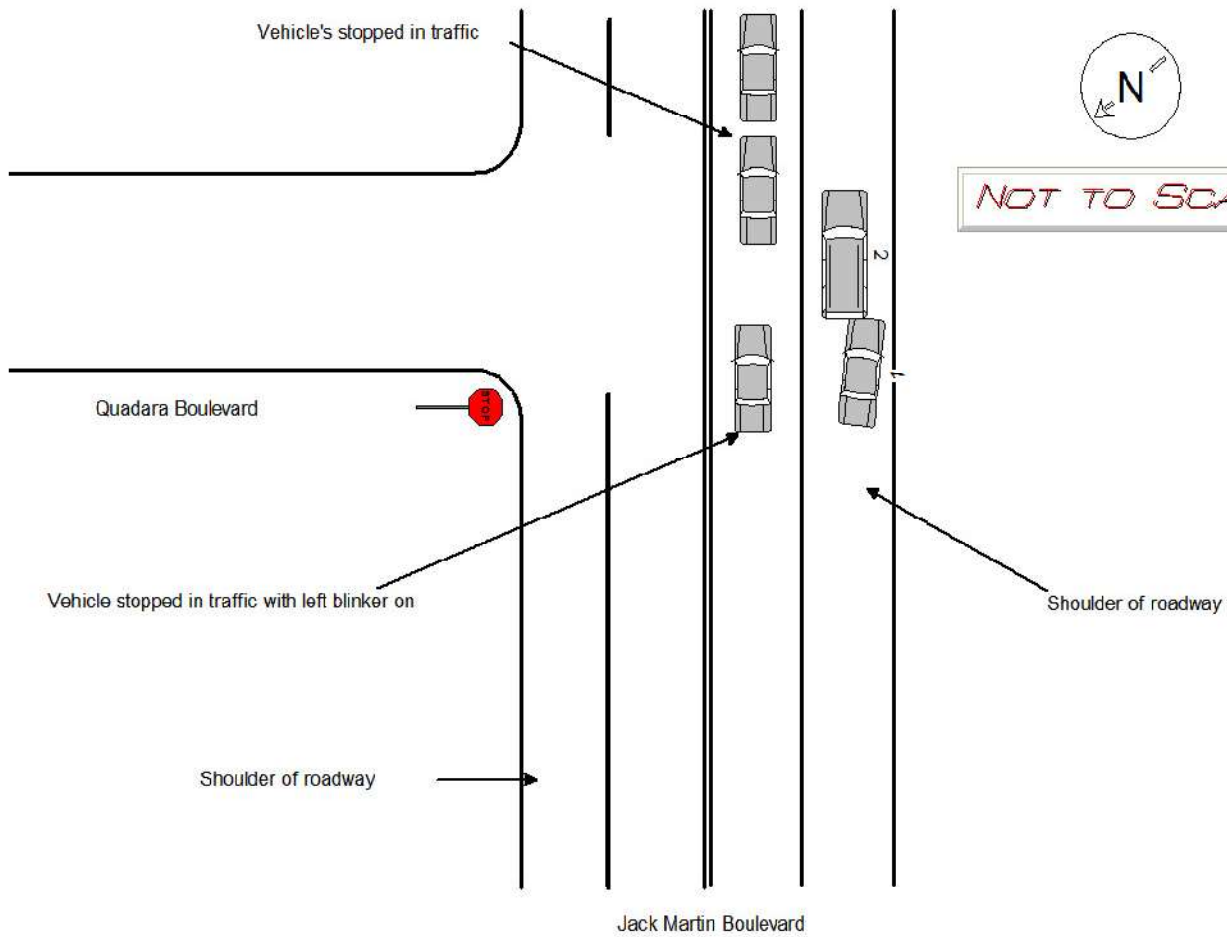
