145. Crash Description/Narrative

The driver of vehicle 1 advised he was traveling west bound on Route 70 approaching Olden St. in the left hand lane when he attempted to merge into the right hand lane in traffic. As he continued forward the front of his vehicle collided with the rear of vehicle 2 which was stopped in traffic.

The driver of vehicle 2 stated he was stopped in traffic on Route 70 (w/b) when the driver of vehicle 1 struck the rear of his vehicle.

Vehicle 1 sustained damage to the front while vehicle 2 sustained damage to the rear. There were no reported injuries at the time of the accident.
