145. Crash Description/Narrative

Vehicle 2 was stopped on Route 70 west, in front of the Royal Farms gas station, approximately 500 feet west of Olden Street. Vehicle 1 was attempting to stop behind Vehicle 2. Vehicle 1 was unable to stop and struck Vehicle 2, causing damage.

Driver 2 advised that, prior to the crash, he was stopped on Rt. 70 west, in front of Royal Farms. Driver 2 advised that he was unaware of the presence of Vehicle 1 until Vehicle 1 struck his vehicle.

Driver 1 advised that, prior to the crash, he was attempting to stop behind Vehicle 2. Driver 1 advised that while attempting to stop, his right foot got stuck on both the gas and the brake pedal at the same time (due to oversized footwear).

Driver 1's pre-crash actions caused this crash to occur.

No injuries were reported on scene. Both vehicles were still in the roadway and at the point of impact upon Police arrival.

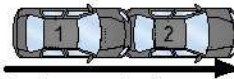
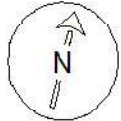
