145. Crash Description/Narrative

Vehicle #1, a marked Brick Township Police vehicle (#42) was traveling west on Route 88. Vehicle #1 stopped at the intersection of Route 88 and Post Road to make a left turn onto Post Road. Vehicle #1 was yielding to Route 88 eastbound traffic when the traffic signal at the intersection turned amber. Driver #1 advised a vehicle, identified as a Ford van, was traveling east on Route 88. Vehicle #1 began to make the left turn onto Post Road. Driver #1 stated despite the traffic signal beginning to turn red, the van proceeded through the intersection without stopping. Driver #1 stated he sped up to avoid being struck by the van, at which time the van hit the brakes and swerved right, crossing in front of Vehicle #1. After speeding up, Vehicle #1 drifted to the right, striking the curb with the front passenger side tire.

Driver #1 advised he then initiated a motor vehicle stop on the van (see case #79862-21). The driver, who was subsequently arrested on unrelated charges, was issued the following summonses by Driver #1:

- Reckless Driving (summons # E21-7529)
- Failure to Observe Traffic Signal (# E21-7530)
- Suspended DL (# E21-7532)

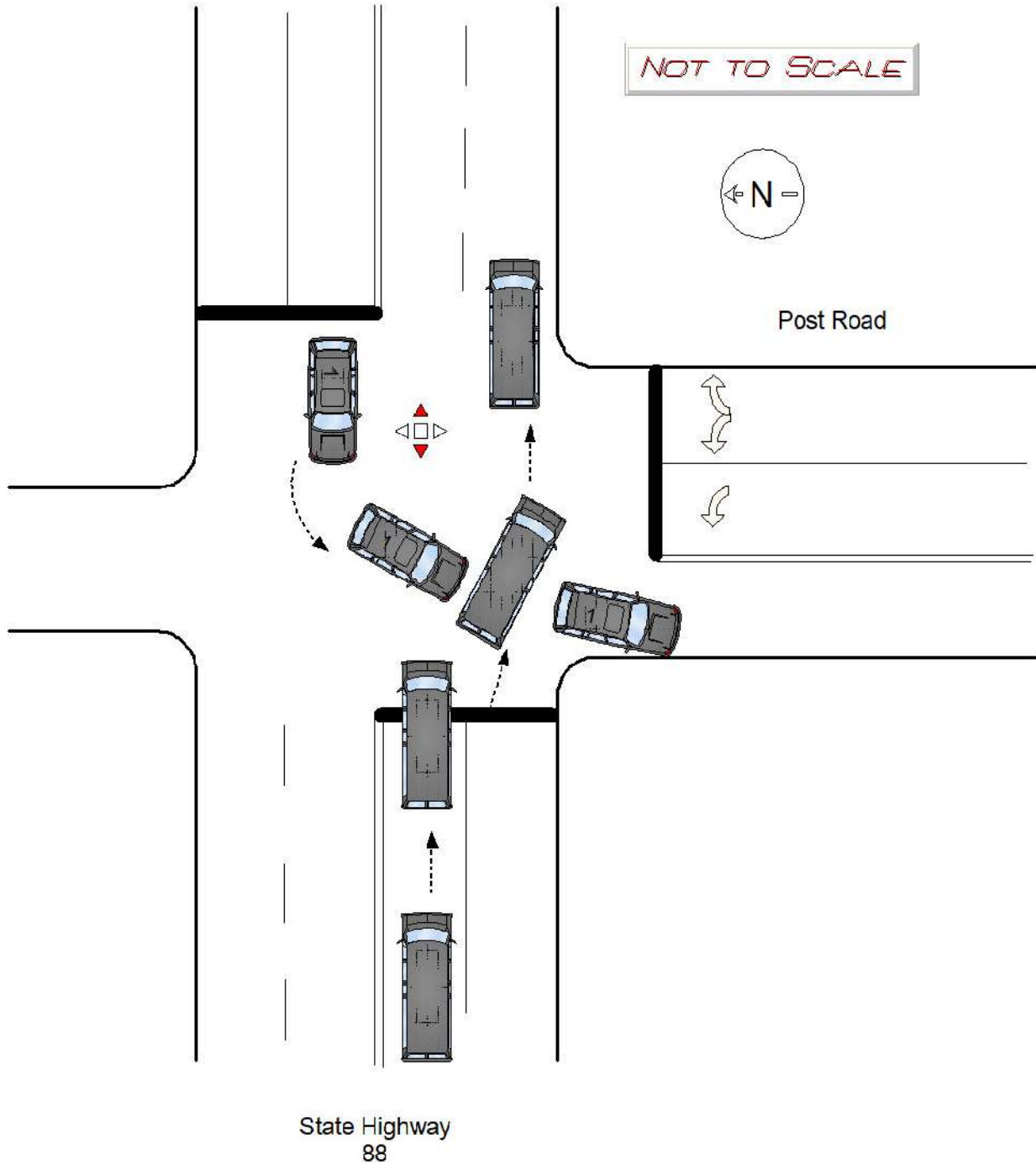
