145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 2 was stopped in traffic for a stop sign located on
 Burrsville Road near the intersection with Route 88. Vehicle 1 was directly behind vehicle 2 on Burrsville Road
 and the front of the vehicle struck the rear of vehicle 2.

Driver 1 stated the following:

He was focusing on the heat in his vehicle as his vehicle traveled forward and struck the rear of vehicle 2.

Driver 2 stated the following:

He was stopped in traffic on Burrsville Road when the rear of his vehicle was struck by the front of vehicle 1.

It was determined on scene that driver 1 was at fault for the accident.

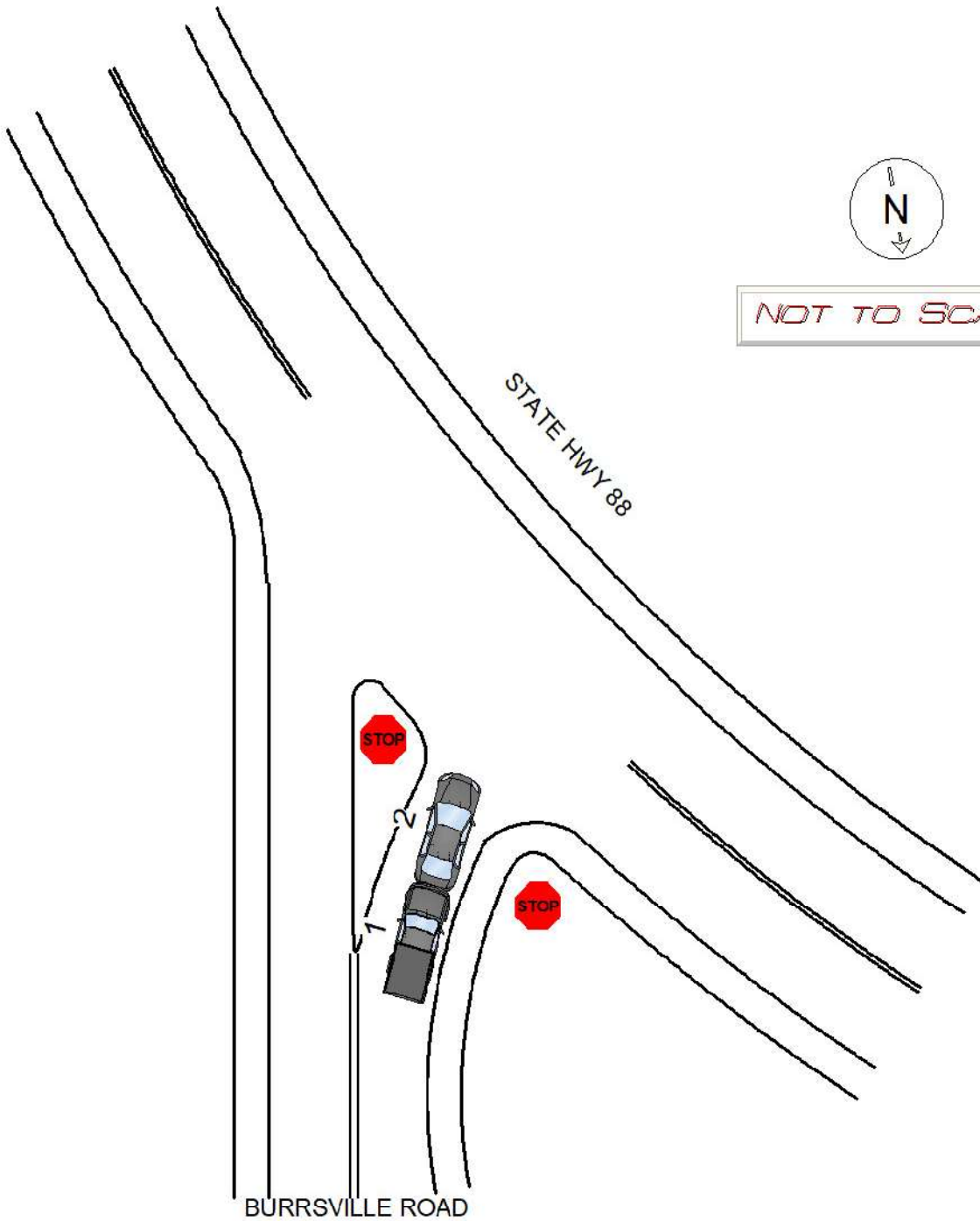
