145. Crash Description/Narrative

Crash investigation reveals a two vehicle, same direction (rear-end) crash. The driver of vehicle 2 (V2) stated he was stopped in the merge lane/entrance ramp to enter onto Route 70 W from Route 88 E. The driver of vehicle 1 (V1) stated she was directly behind V2 on said merge lane/entrance ramp.

As V2 was stopped, the driver of V1 stated she was looking to her left observing traffic traveling on Route 70 W. The driver of V1 stated she believed that V2 had begun to merge onto Route 70 W at which time she began accelerating forward. Due to V2 being stopped as V1 was accelerating forward/merging onto Route 70 W, the front end of V1 crashed into the rear of V2.

No injuries were reported by both drivers. V1 sustained minor damage and was driven from the scene. V2 sustained no visible damage and was left at the scene. The driver of V1 is at fault for the crash.

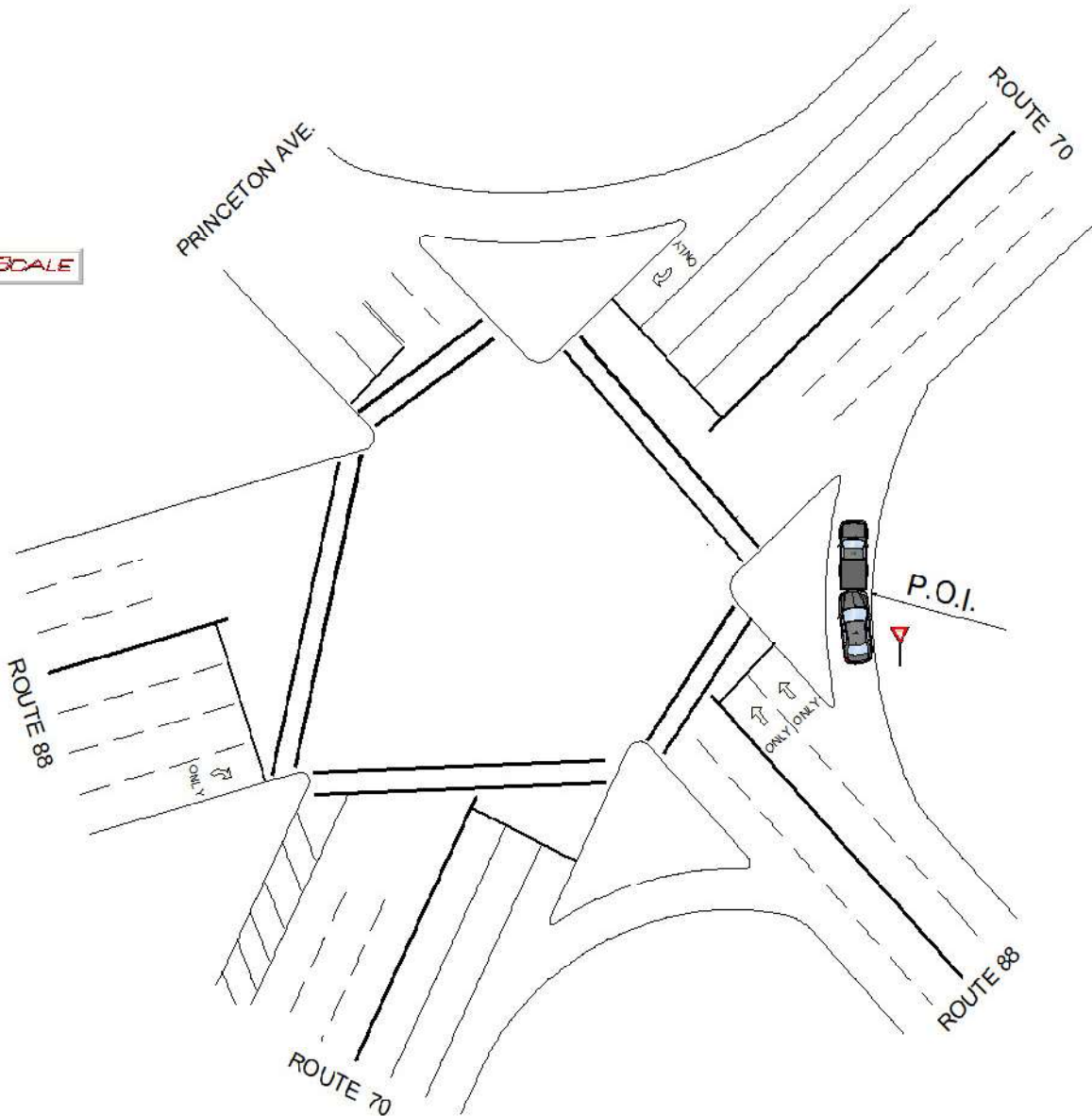
