145. Crash Description/Narrative

Vehicle 1 was traveling west bound on Route 88 approximately 50 feet east of Barb Lane. Vehicle 2 was directly in front of Vehicle 1 slowly driving west. Vehicle 1 did not stop in time and struck the rear of Vehicle 2.

In speaking with the driver of Vehicle 1, he stated that he was driving west of Route 88 and was attempting to grab his cigarettes which fell on his driver side door. Driver 1 stated he looked down for a second and when he looked up saw Vehicle 2 and realized he was not going to be able to stop in time and struck the rear bumper. Driver 1 stated it was his fault and he knew it.

In speaking with the driver of Vehicle 2, she stated she was slowly driving as there was a little bit of traffic and the next thing she knew, she felt a bump from behind and realized the rear of her vehicle had been struck by Vehicle 1.

No injuries were reported and Vehicle 1 was towed due to being disabled and having heavy front end damage. Vehicle 2 had moderate damage to the rear bumper.

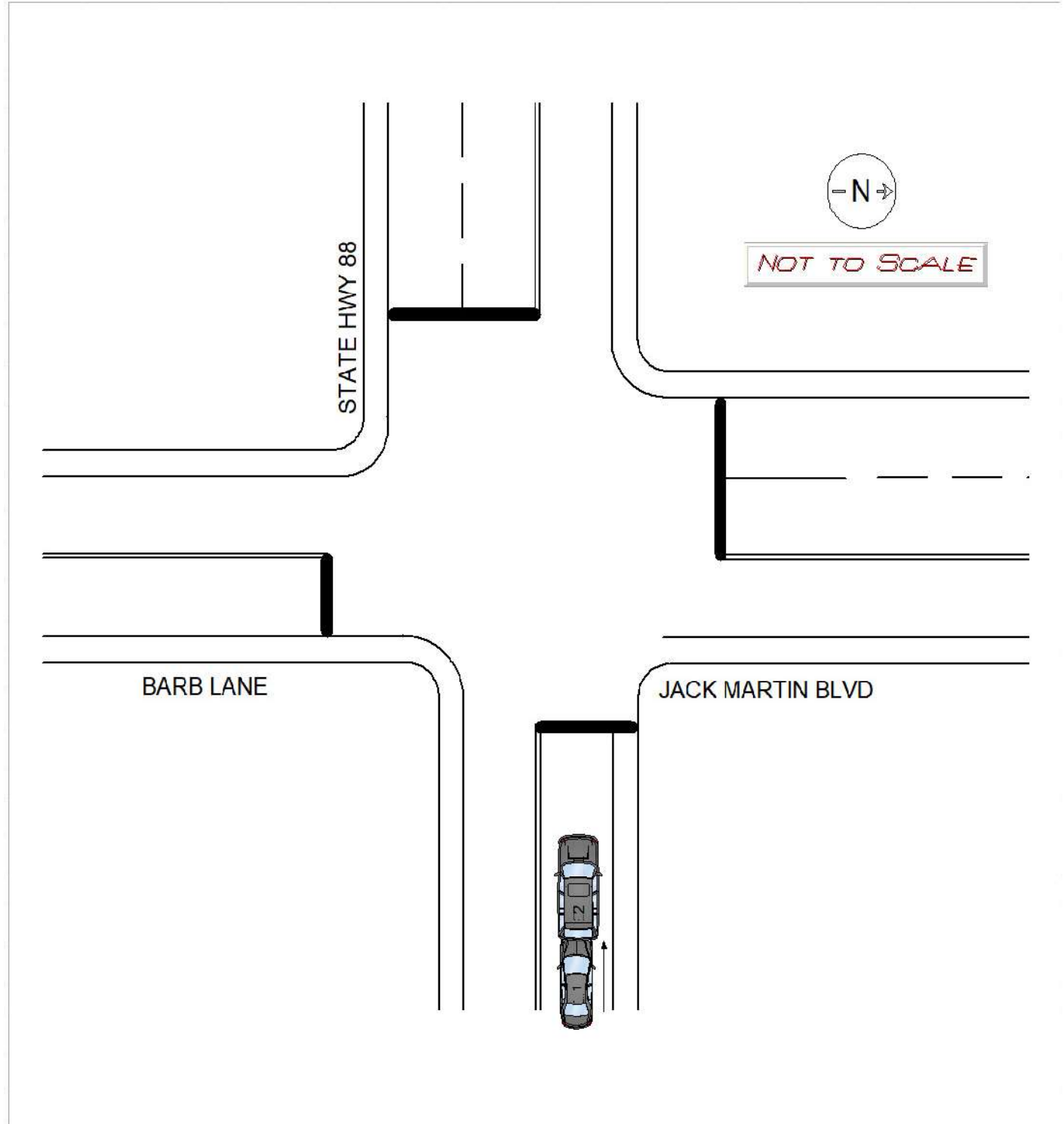
