145. Crash Description/Narrative

A motor vehicle crash occurred on Rt. 88 eastbound, near Van Zile Rd. and involved two vehicles.

Vehicle #1 was traveling eastbound on Rt. 88. Driver #1 stated he was looking down at his phone for navigation.

When he looked back up he noticed Vehicle #2 attempting to turn left into Laurel Square plaza. He attempted to stop but was unable to and stuck the rear of Vehicle #2.

Vehicle #2 was traveling eastbound on Rt. 88 turning left into Laurel Square plaza. Driver #2 stated she was stopped attempting to turn left when she was struck from the rear.

Driver #1 had a complaint of pain in his hip, ribs and chest due to his seatbelt. Driver #2 stated she was not injured on scene.

Vehicle #1 had disabling damage to the front of vehicle and was towed by PPTD towing. Vehicle #2 had moderate damage to the rear of the vehicle and was able to be driven off scene.
