145. Crash Description/Narrative

Vehicle #1 was traveling south on Burrsville Road, just past the intersection of Jack Martin Blvd. Vehicle #2 was traveling north Burrsville Road, just passed the intersection of State Highway 88.

Driver #1 stated she was trying to make a left turn from Burrsville Road into the rear parking lot of The United Medical Park, located at 495 Jack Martin Blvd. She slowed down and put on her left turn signal and did not see any vehicles coming in front of her. As she began turning, the rear of her vehicle was struck by Vehicle #2.

Driver #1 stated she did not see Vehicle #2 due to the sun being in her eyes.

Driver #2 stated he was driving straight on Burrsville Road when Vehicle #1 made a left turn in front of him. He was unable to avoid the collision and the front of his vehicle struck the rear of Vehicle #1.

Based on my observations and statements made by both drivers, I determined Vehicle #1 to be at fault for the crash.

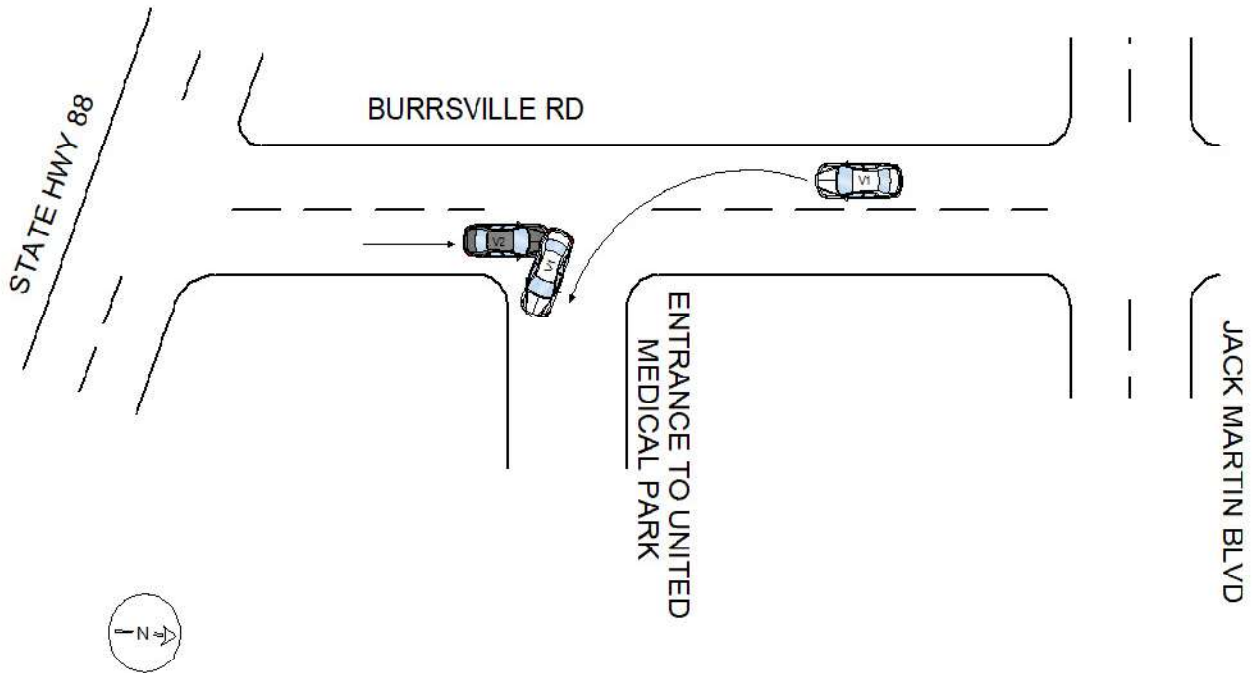
