145. Crash Description/Narrative

Vehicles 1 and 2 were exiting the Walmart parking lot located at 1872 State Highway 88 onto Route 88 westbound. Vehicle 1 was behind Vehicle 2. Vehicle 2 was stopped for oncoming traffic.

The driver of Vehicle 1 stated that as he was looking over his left shoulder for oncoming traffic, he took his foot off the brake and the front of his car rolled forward into the rear of Vehicle 2.

No injuries were reported at the scene. Cosmetic damage to the rear bumper of Vehicle 2 only. No motor vehicle summonses were issued, and both vehicles were driven from the scene.

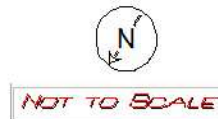
