145. Crash Description/Narrative

A motor vehicle crash occurred on Jack Martin Blvd at the intersection to Burrsville Road.

Driver of Vehicle #1 advised she was traveling east on Burrsville Road towards the intersection of Jack Martin Blvd. Driver #1 advised the traffic signal turned yellow as she was entering the intersection. Driver #1 advised Vehicle #2 turned left onto Jack Martin Blvd in front of her. Driver #1 advised she attempted to stop, but struck Vehicle #2.

There was damage to the front passenger bumper of Vehicle #1.

Driver of Vehicle #2 advised he was traveling west on Burrsville Road at the intersection to Jack Martin Blvd, waiting to turn left onto Jack Martin Blvd. Driver #2 advised the traffic signal turned yellow, he paused for a second believing the intersection was clear, and began to turn left onto Jack Martin Blvd. Driver #2 advised he was struck by Vehicle #1 while turning left onto Jack Martin Blvd.

There was damage to the driver side door of Vehicle #2.

Driver #2 had complaint of pain in her stomach. She refused further medical treatment. The passenger of Vehicle #1 initially stated he was not injured. When his parents arrived, he had pain on his right side with the most pain in his hip. His parents transported him to Ocean Medical Center in their vehicle in reference to this.

While turning left onto Jack Martin Blvd, Vehicle #2 failed to observe Vehicle #1 traveling west on Burrsville Road and the vehicles collided.

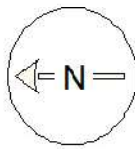
