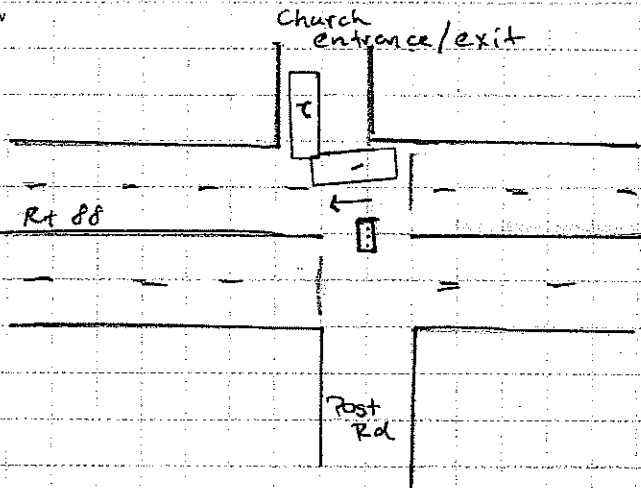

145. Crash Description/Narrative

Vehicle 2 was exiting the lot to enter the roadway. Vehicle 1 was traveling west on Rt 88. The crash occurred when the front of vehicle 1 struck the front side of vehicle 2. The driver of vehicle 1 stated the other car had a red light. The driver of vehicle 2 stated she had a green light. A witness, who provided a written statement, advised vehicle 1 had run the red light.

No injuries were reported. Both vehicles were towed because they were disabled. The driver of vehicle 1 was issued summons 1506-T-155483 for 3P:4-22
