145. Crash Description/Narrative

Driver of V1 stated he was parked in a parking spot on the corner of the parking lot of Walmart. Driver 1 stated that as he began to pull out of the parking spot V2 made a fast right turn at a high rate of speed and cut in front of his vehicle. V1 then crashed into V2.

Driver of V2 stated she was making a right turn into the parking aisle when V1 pulled out of their spot and crashed into the passenger side door of her vehicle.

Based on my investigation and observations on scene I determined V1 to be at fault for the motor vehicle crash.
