145. Crash Description/Narrative

Vehicle #1 collided Vehicle #2 (Mini Bus with no passengers) while backing out of a parking space in the parking

lot of 459 Jack Martin Boulevard.

The Driver of Vehicle #1 stated she attempted to back out of her parking space and struck Vehicle #2. Driver #1

stated she did check her rearview prior to backing out and did not observe Vehicle #2 behind her. Vehicle #1 had

minor damage on the left rear end.

The Driver of Vehicle #2 stated she was stopped behind a vehicle in front of her in the parking lot when her

vehicle was struck by Vehicle #1. Driver #2 stated the vehicle was struck along the rear of the passengers side.

I did not observe and damage to Vehicle #2.

Based on my observations and statements made by both parties I found the Driver of Vehicle #1 at fault for the

crash for backing unsafely.

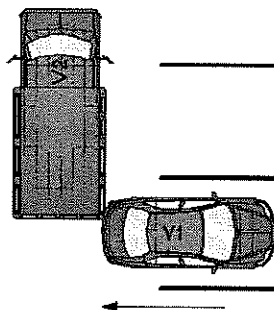
