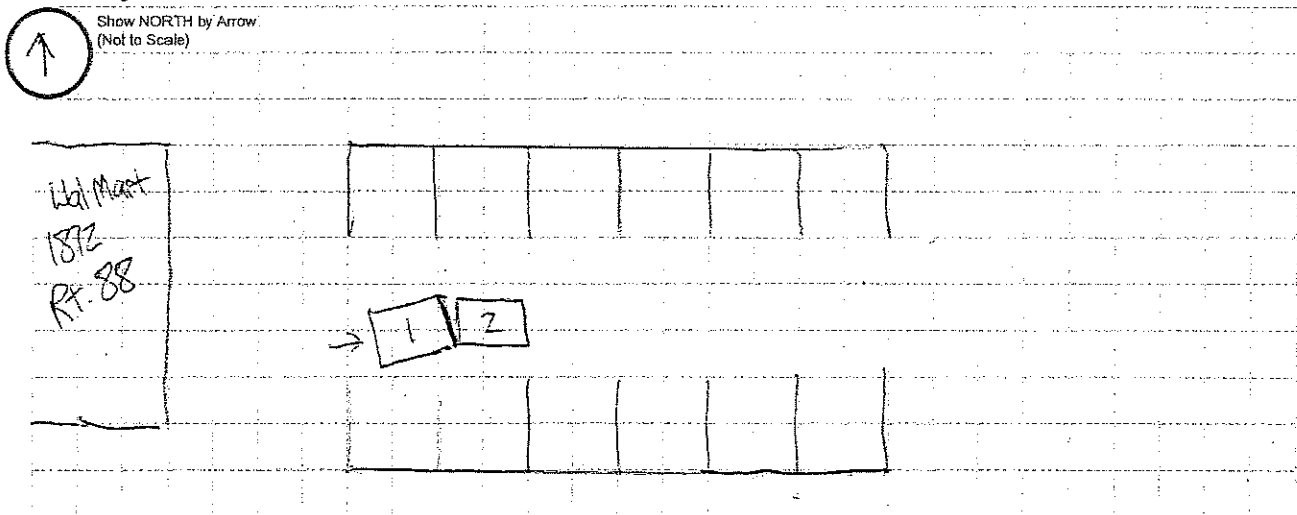

145. Crash Description/Narrative

A Motor vehicle crash occurred in the parking lot of Wal Mart (1872 Rt. 88). Driver of Vehicle #2 stated she was stopped in traffic and observed Vehicle #1's reverse lights turn on. Driver #2 advised the vehicle began moving in reverse towards her vehicle and she beeped her horn. Driver #2 advised her vehicle was struck by Vehicle #1. Driver #2 advised Vehicle #1 moved forward turning left and parking in the next lot. Vehicle #1 advised she was in reverse, couldn't see out her rear window, but heard the back-up sensor beeping. Vehicle #1 did not realize she struck Vehicle #2 and traveled to another parking spot.

There were no reported injuries while on scene.

While in reverse, Vehicle #1 struck Vehicle #2.

Driver #1 is the at-fault driver for driver inattention and backing unsafely.

There was minor damage to both vehicles.

Video surveillance of the crash was placed onto a DVD by Wal Mart Loss Prevention. The DVD was placed into property.
