**145. Crash Description/Narrative**

Both vehicles were backing out of their respective parking spots when each struck the other in the rear.

Driver #1 advised that she looked to the left and right before backing out, but did not see Vehicle #2 behind her. Driver #1 further stated she was more concerned about making sure there were no pedestrians walking behind her. Driver #2 advised that he was just about completely backed out of his spot when he was suddenly struck in the rear by Vehicle #1. Driver #2 advised that he did not see vehicle #1 backing up.

Based upon my observations, and statements made by both drivers, I find both subjects at fault for unsafe backing. Vehicle #1 sustained minor damage to the rear hatch, and there was no visible damage to Vehicle #2.

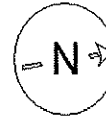
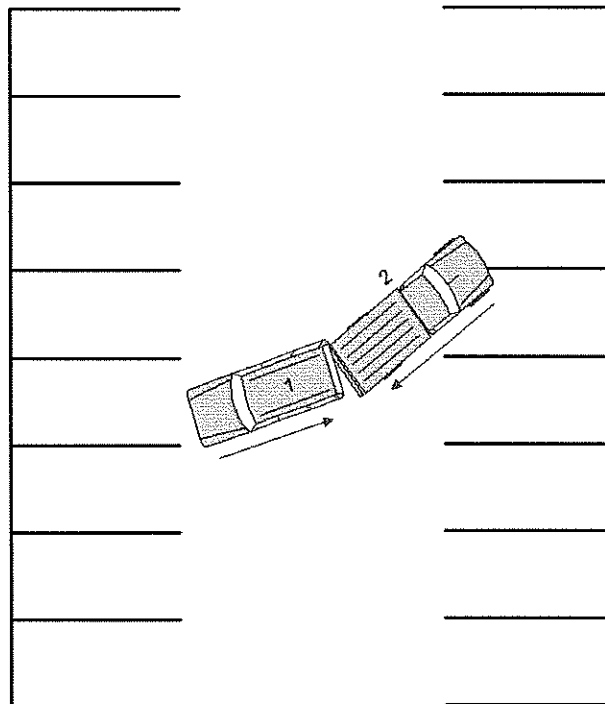
