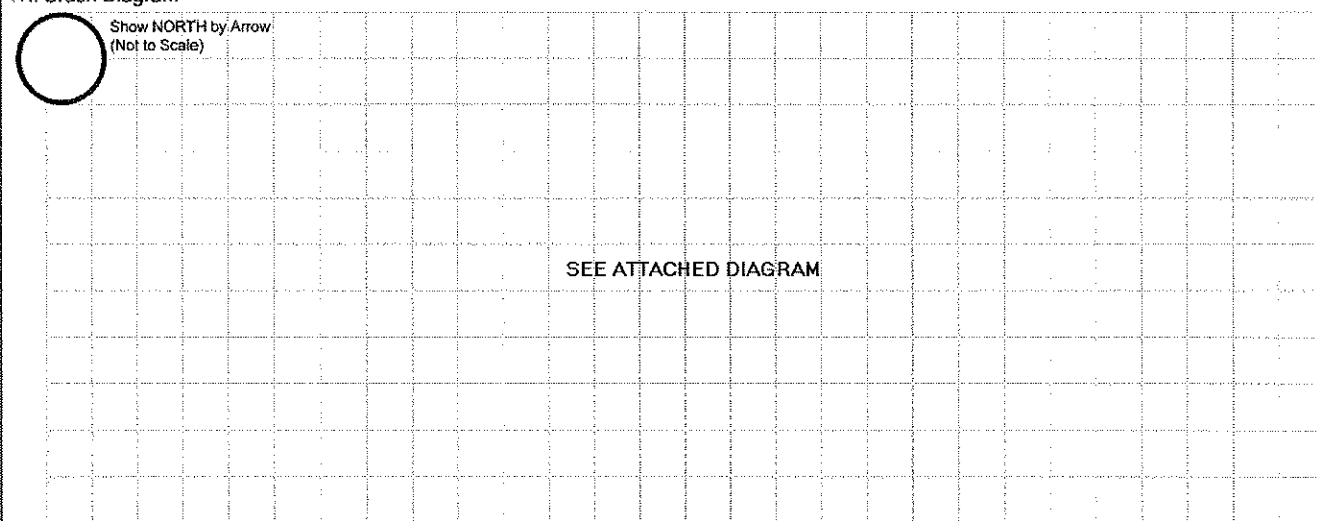

145. Crash Description/Narrative

Vehicle 1 was traveling East on Rt 70 in the right most lane, approaching the red-lit traffic signal at the intersection of Rt 70 and Olden St. V2 was traveling North on Olden St in the right lane, towards the green-lit traffic signal at the intersection with Rt 70. V1 failed to stop for the red light and entered the intersection of Rt 70 and Olden St, in front of V2. V2 traveled forward into the intersection, having the green light, and struck the rear passenger side of V1 as it traveled past. V1 spun approximately 180 degrees around and came to rest in the right lane of Rt 70 East bound, East of the intersection with Olden St. V2 came to rest at the point of impact, within the intersection.

Driver 1 stated his wife, who was seated in the front passenger seat, was trying to read GPS directions to him to locate Olden St. Driver 1 stated he was paying attention to the street signs and intersections and may have missed the red-light indicating he should have stopped. Driver 1 did not complain of any injuries. His wife, seated in the front passenger seat, complained of pain to her left arm. Both refused any medical attention.

Their vehicle was disabled and was towed by Rt 88 Auto Body from the scene.

Driver 2 stated she had a green light and traveled forward North into the intersection as V1 ran the red light and

passed by in front of her, causing the front of her vehicle to contact the rear passenger side of V1. Driver 2 had a complaint of pain to her left wrist and chest but refused any medical attention. Her vehicle was disabled and was towed by Lepore's Towing from the scene.

Based upon my observations and statements by both parties, I found Driver 1 to be at fault for failing to stop for the red traffic signal at the intersection of Rt 70 East bound with Olden St. Driver 1 was issued a citation for 39:4-81a.
