145. Crash Description/Narrative

A motor vehicle crash occurred on Route 70 approximately 25 feet west of Jack Martin Blvd.

Driver of Vehicle #1 advised she was traveling west on Route 70 in the right lane. She advised she became distracted and swerved into the left lane of travel, striking Vehicle #2.

Driver of Vehicle #2 advised he was traveling west on Route 70 in the left lane. Driver #2 advised Vehicle #1 swerved into his lane of travel, striking his vehicle.

There were no reported injuries while on scene.

Vehicle #1 swerved into Vehicle #2's lane of travel, striking Vehicle #2.

Vehicle #1 is the at fault driver for improper lane change and driver inattention. Driver #1 received the following summonses: 1506 E17 006104 for 39:4-97, careless driving and 1506 E17 006105 for 39:3-29A, failure to possess a drivers license.

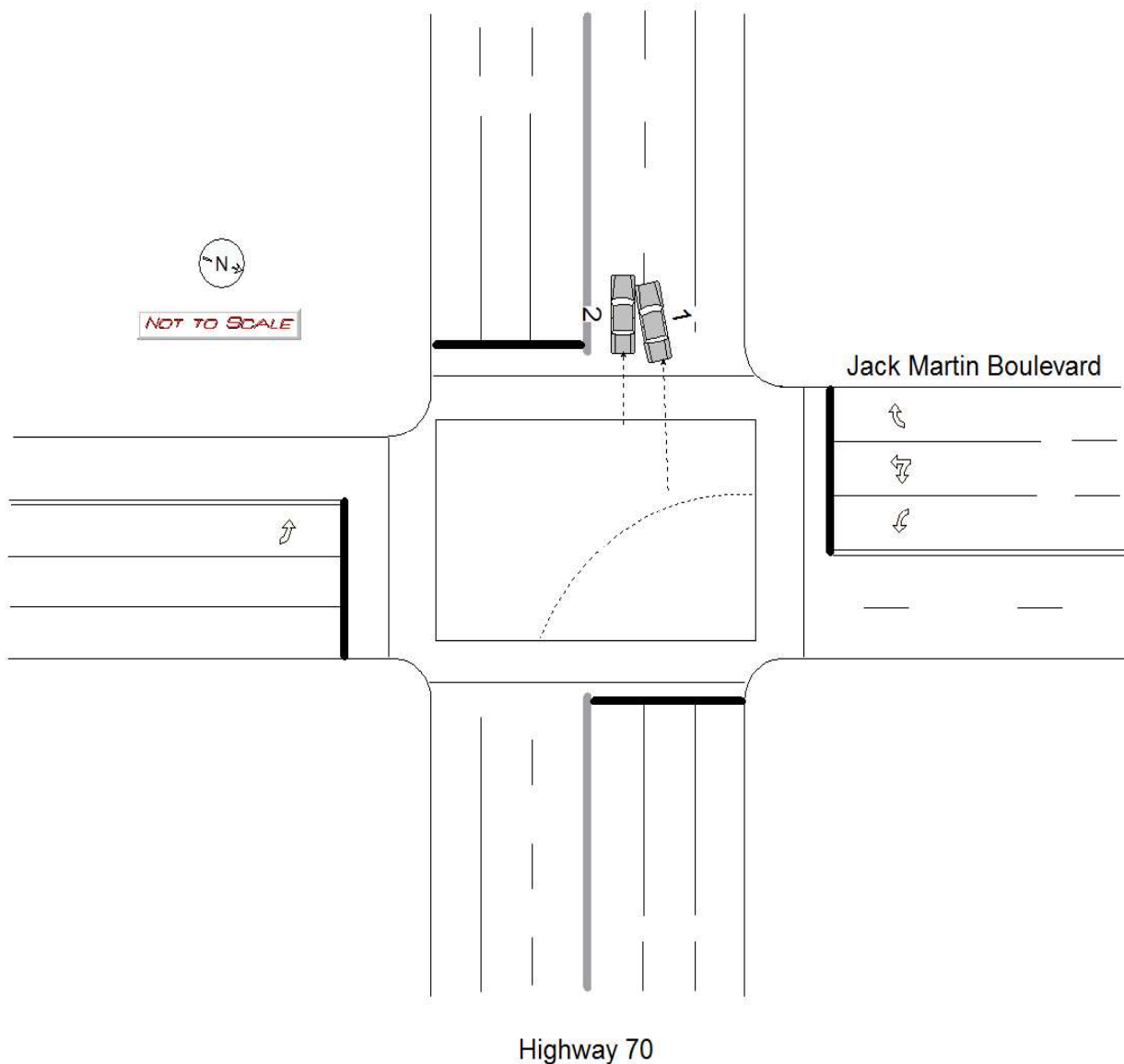
