145. Crash Description/Narrative

On 12/16/21 at 1515 hours I was dispatched to the area of Rt 88 and Truman Dr in reference to a two car motor vehicle accident. Dispatch advised one of the vehicles had left the scene due to a pediatric doctor appointment for their infant. However, the driver of that vehicle left their information with the other driver involved. Upon my arrival I observed vehicle 2 had moved in to a nearby parking lot for their safety.

The driver of vehicle 2 advised she was in the parking lot of 2119 Rt 88 after leaving the doctors office with her grandson. When leaving the parking lot she stopped at the exit and waited for traffic to clear so she could turn left on to Rt 88 west bound. She had an opening and entered the roadway. As the driver of vehicle 2 was turning she observed vehicle 1 turning left, directly across from her, off of Truman Dr on to Rt 88 east bound. The driver of vehicle 2 came to a stop and utilized their horn to alert the driver of vehicle 1. The driver of vehicle 1 initially applied their breaks, but then suddenly accelerated again. Due to this, vehicle 1 ultimately crashed in to vehicle 2.

While obtaining information from the driver of vehicle 2, the driver of vehicle 1 called to advised she was home. I responded to the residence and spoke with the driver of vehicle 1. The driver of vehicle 1 advised she

was attempting to turn left on to Rt 88 east bound from Truman Dr. Prior to turning on to Rt 88 she observed she had an opening and entered the roadway. As she crossed over the west bound lane she looked to her right to ensure the east bound lane was still clear. As she turned her head back to her left she noticed vehicle 2 exiting the parking lot 2119 Rt 88. The driver of vehicle 1 attempted to swerve right to avoid vehicle 2, but the vehicles crashed in to each other.

Investigation at the scene revealed vehicle 1 to be at fault. Both vehicles were turning left on to Rt 88 directly across from one another. Both vehicles had an opening to enter traffic and both did so. The driver of vehicle 2 observed vehicle 1, stopped and utilized their horn to alert them. The driver of vehicle 1 failed to observe vehicle 2 entering the roadway at approximately the same time and crashed in to it. The lower left front of vehicle 1 crashed in to the lower left front of vehicle 2. No injuries were reported and both vehicles were driven away from the scene.

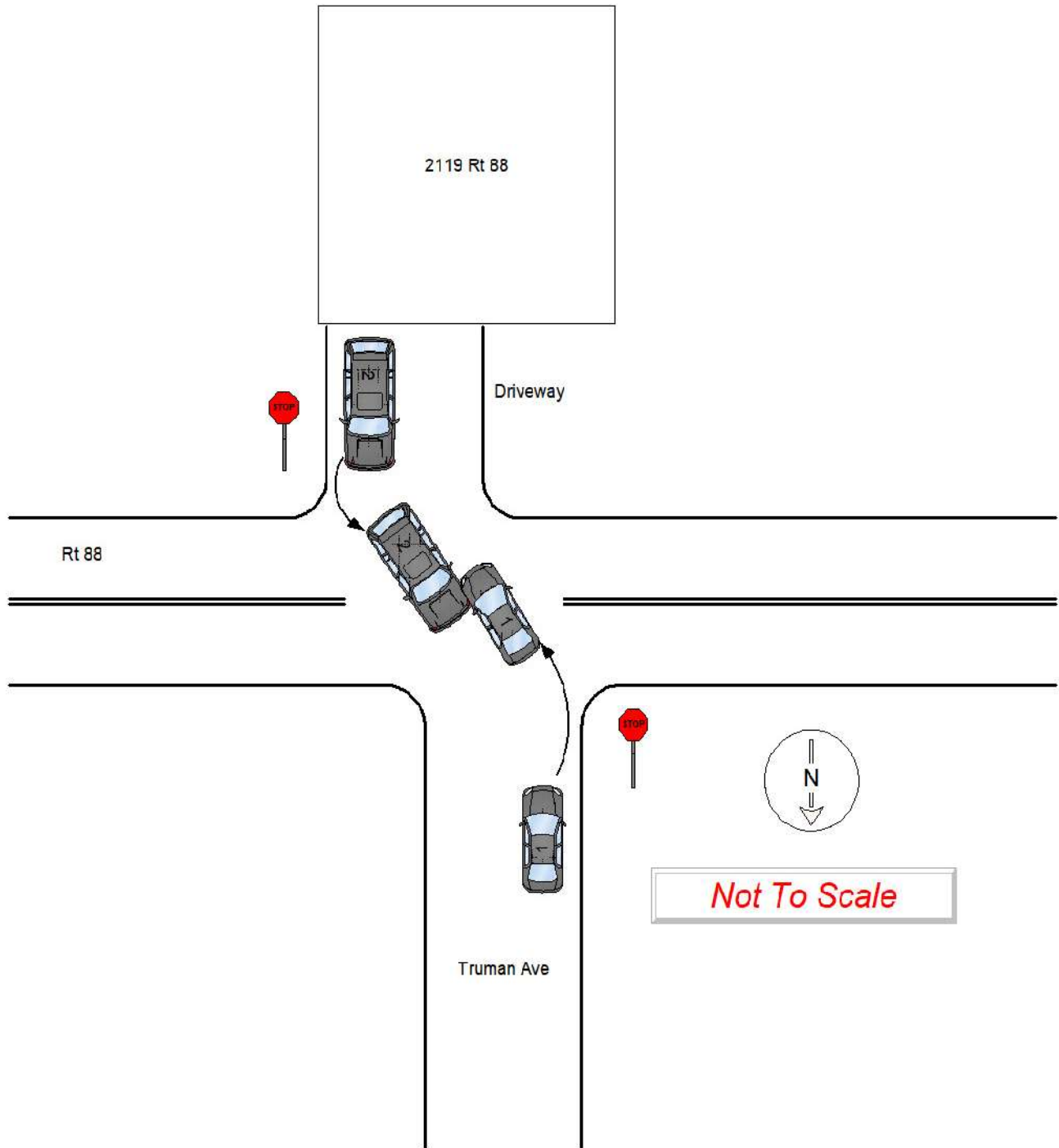
