145. Crash Description/Narrative

Vehicle 2 was stopped in traffic on RT 88 E attempting to turn into the Brandywine living center. Vehicle 1 was

traveling RT 88 E and attempted to pass vehicle 1 on the right. Vehicle 2 began to turn and was struck by Vehicle

1.

I spoke to driver 1 who stated the following: he was driving when vehicle 2 stopped short to turn into Brandywine

and missed the turn. Vehicle 2 then began to drive again and before he could swerve he struck vehicle 2.

Next I spoke to driver 2 who stated the following: she was stopped in traffic attempting to turn into Brandywine

when she was struck in the back. Due to the crash she could no longer turn into Brandywine so she turned into the

next plaza to turn around and head back to Brandywine.

The passenger in vehicle 2 was a non verbal female dementia patient who was pointing to her chest when I tried to

ask her if she was ok. Brick EMS transported her to OMC for further evaluation to air on the side of caution.

After speaking to both parties and observing the crash, I determined vehicle 1 was at fault for the crash for

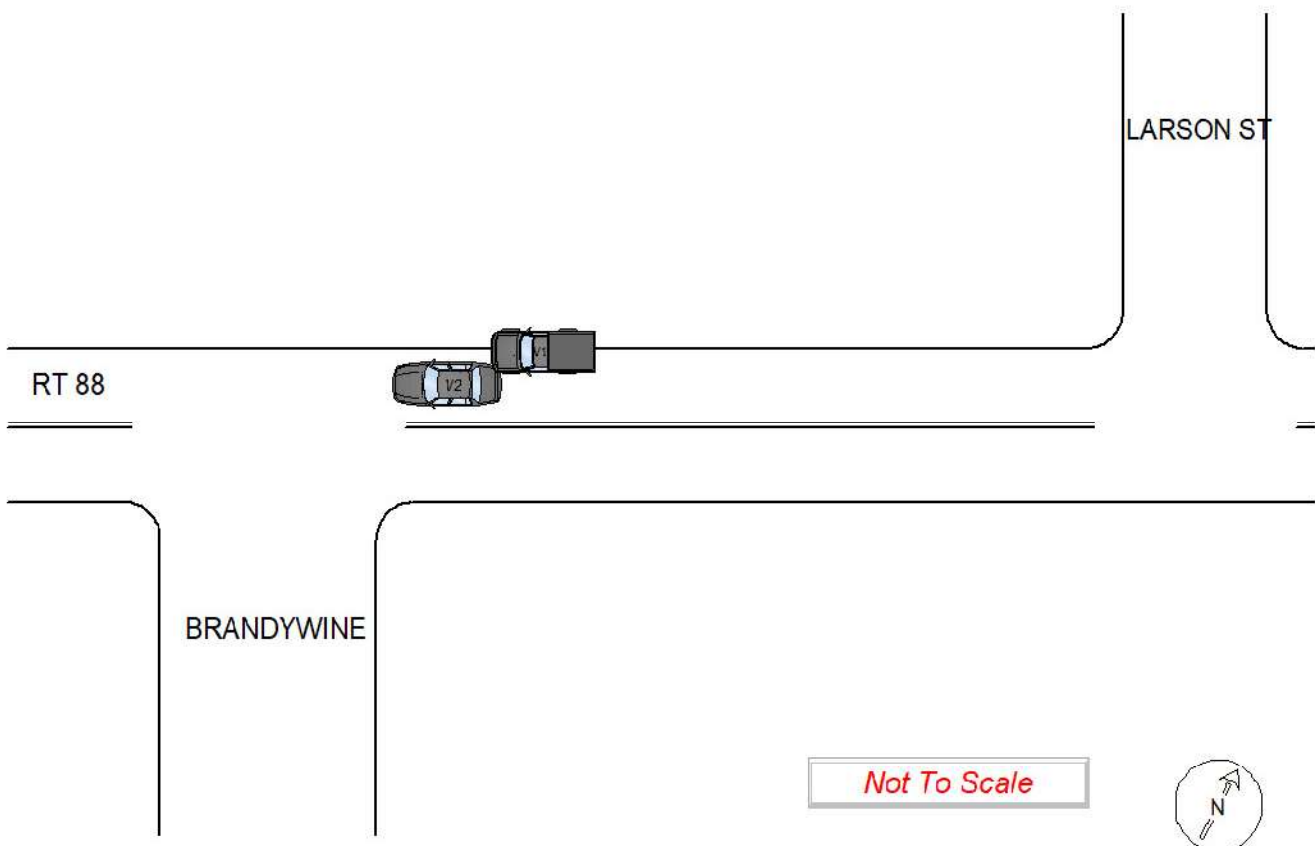
