145. Crash Description/Narrative

On January 1, 2022 I responded to the intersection of Route 88 and Jack Martin Blvd for a three vehicle motor vehicle crash. Prior to my arrival, Vehicle #1 which is described as a red f-150 pick up truck with a cap on the back left the scene. Upon my arrival, I observed two vehicles on the side of the road. Vehicle #2 had heavy rear disabling damage and front driver side damage to the vehicle. Vehicle #3 had driver side rear disabling damage.

Driver #2 explained he was stopped at the traffic light at Route 88 and Jack Martin blvd when vehicle #1 crashed into the rear of his vehicle. When vehicle #1 crash into the rear of his vehicle it caused him to push forward causing him to crash into the vehicle making a left onto Route 88. After crashing into the vehicle #3 he observed the possible red f-150 pickup truck run the red light and continued on Route 88 Westbound towards the interchange.

Driver #3 explained she was making a left turn from Jack Martin Blvd to Route 88 (eastbound) when vehicle #2 crashed into the rear of her vehicle.

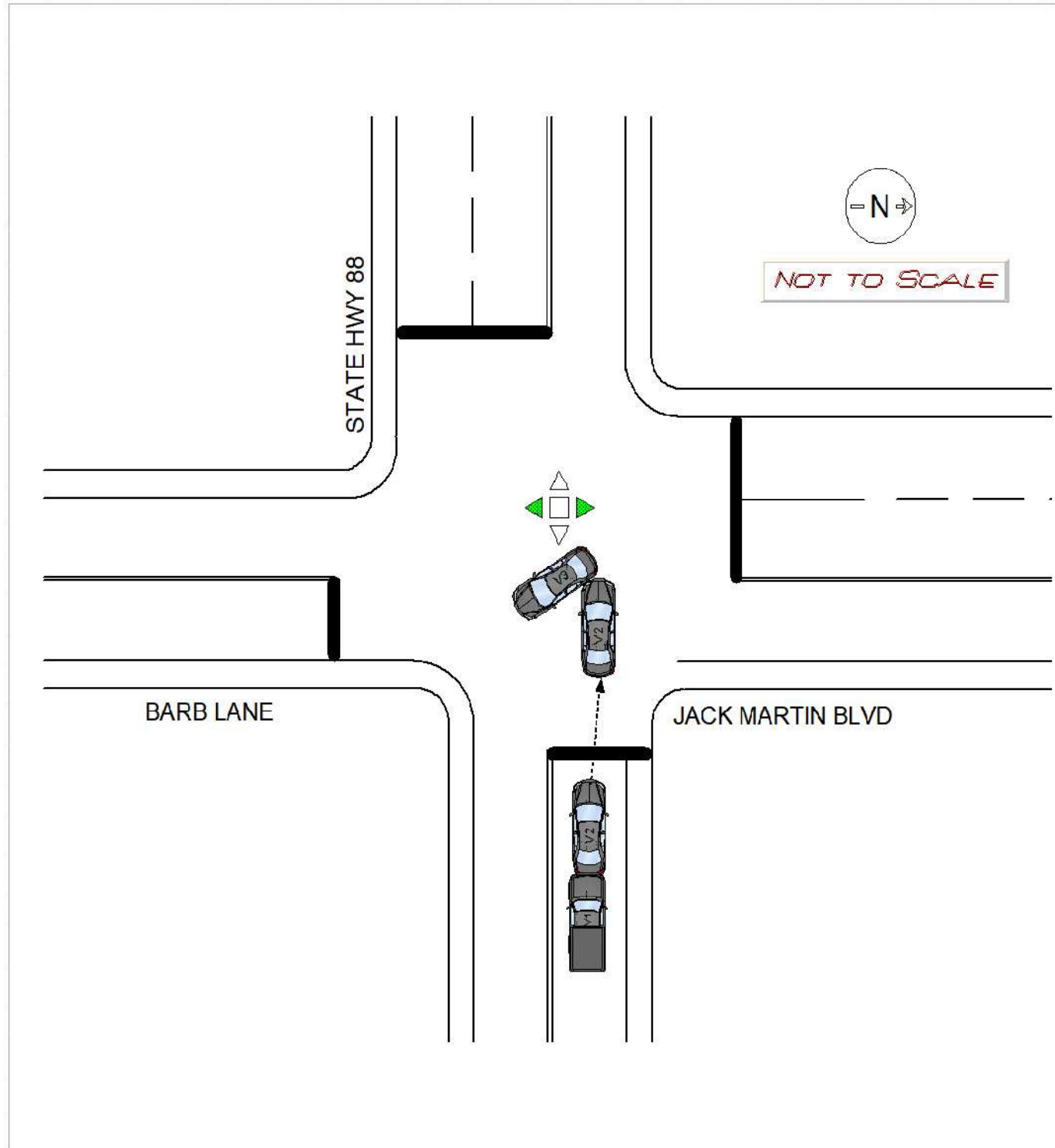
