145. Crash Description/Narrative

Vehicle 1 was in the Hackensack Urgent Care parking lot (2125 Rt. 88) attempting to drive through the parking lot.

Vehicle 2 was in the Urgent Care parking lot stopped in line waiting to be tested. Vehicle 1 attempted to drive pass Vehicle 2 and struck the left middle panel of Vehicle 2. Vehicle 1 received minor damage to the lower front right panel. Vehicle 2 received minor damage to the left middle panel.

Driver of Vehicle 1 stated he was attempting to go pass Vehicle 2. Driver 1 stated he thought he had enough room to fit his vehicle pass Vehicle 2. Driver 1 stated he did not have enough room and struck Vehicle 2.

Driver of Vehicle 2 stated she was waiting in the traffic line waiting to be tested. Driver 2 stated Vehicle 1 was attempting to go passed her and struck her vehicle.

From my investigation, I find Driver of Vehicle 1 at fault for the crash.

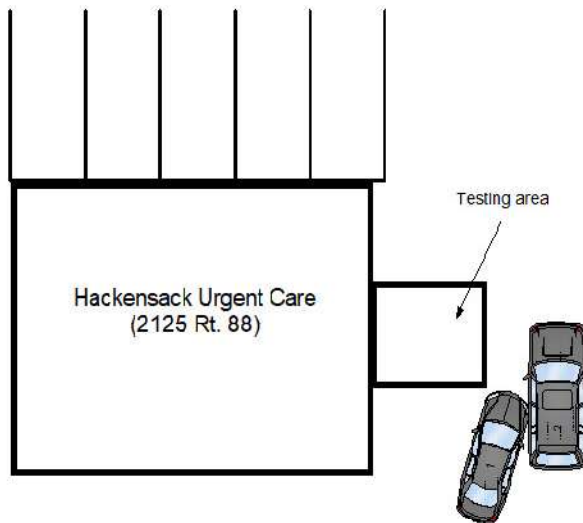
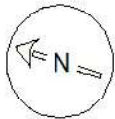

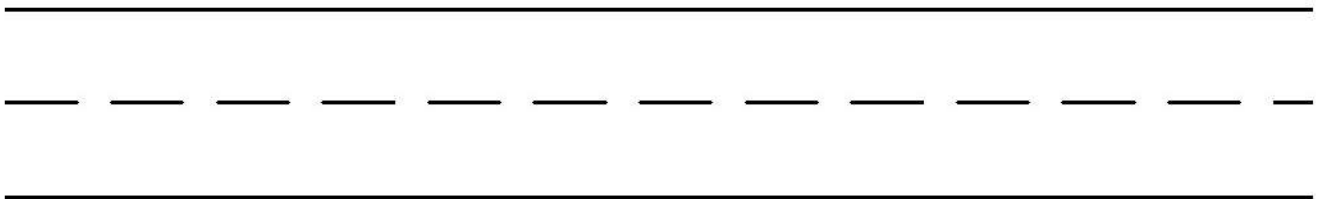
