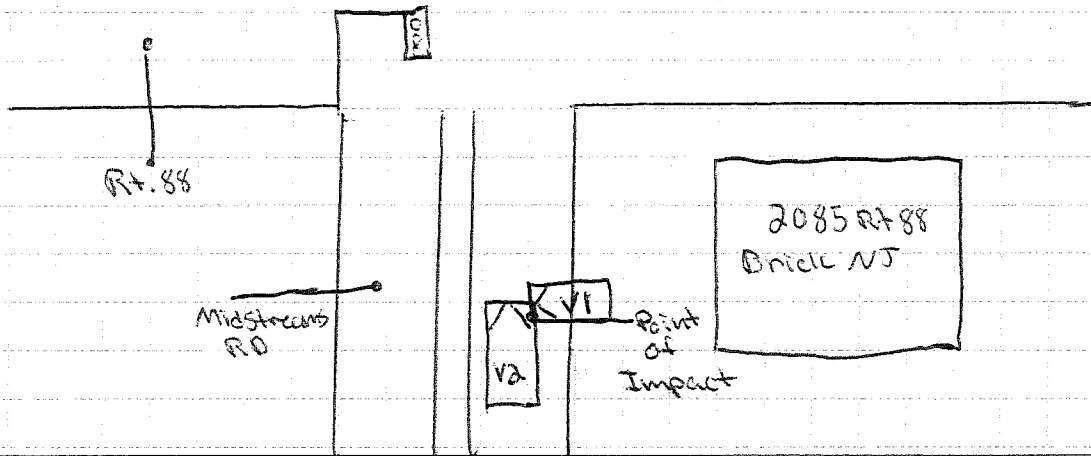

145. Crash Description/Narrative

Vehicle one was turning left out of 2085 Rt 88. Vehicle Two was traveling north on Midstreams Rd. while making the left turn V1 struck V2.

Driver of V1 stated he did not see V2 before striking it.

Driver of V2 stated she was traveling on Midstreams Rd. when V2 pulled out of 2085 Rt 88 and struck her vehicle. The passenger of V2 had a cut on her right arm and was treated on scene by Brick EMS. Driver of V1 had complaint of pain in his eye but refused medical treatment.
