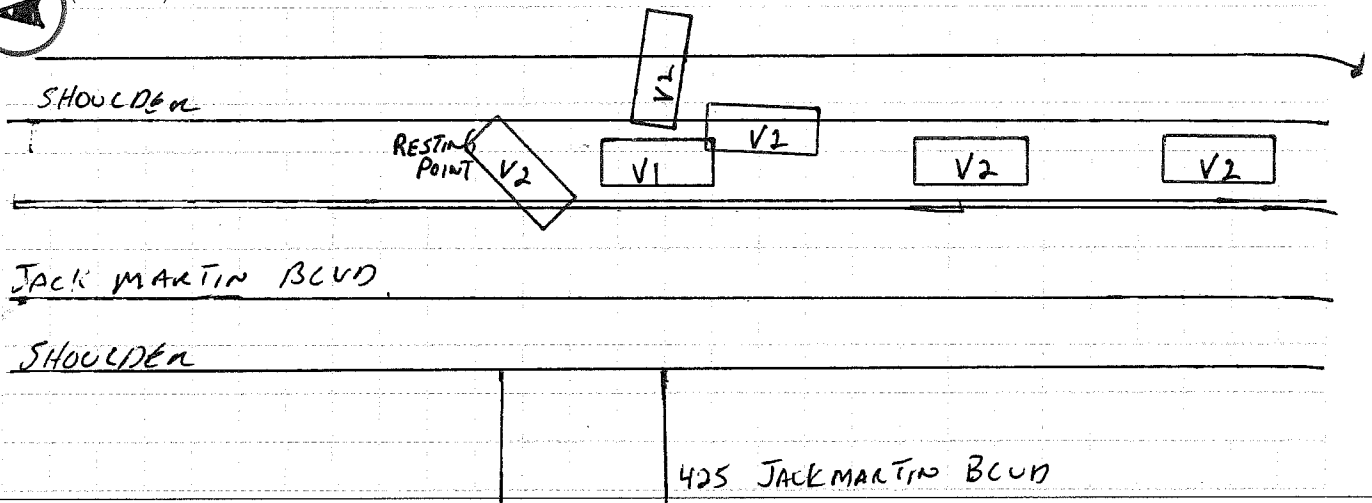

145. Crash Description/Narrative

VEHICLE #1 WAS TRAVELING NORTH ON JACK MARTIN BLVD AND STOPPED TO MAKE A LEFT TURN INTO 425 JACK MARTIN BLVD. VEHICLE #2 WAS TRAVELING NORTH ON JACK MARTIN BLVD AND COLLIDED INTO THE REAR PASSENGER SIDE OF VEHICLE #1. AFTER THE COLLISION VEHICLE #2 SPUN AROUND VEHICLE #1 AND WAS FACING SOUTH ON JACK MARTIN BLVD.

DRIVER #1 STATED THAT SHE WAS STOPPED TO MAKE A LEFT TURN INTO 425 JACK MARTIN BLVD. WHEN SHE LOOKED IN HER REAR VIEW MIRROR SHE OBSERVED VEHICLE #2 TRAVELING AT A HIGH RATE OF SPEED BEFORE COLLIDING INTO HER VEHICLE.

DRIVER #2 STATED THAT SHE WAS TRAVELING NORTH ON JACK MARTIN BLVD EATING HER FOOD. ALL OF SUDEN VEHICLE #1 WAS STOPPED IN FRONT OF HER AND SHE COLLIDED INTO THE VEHICLE.
