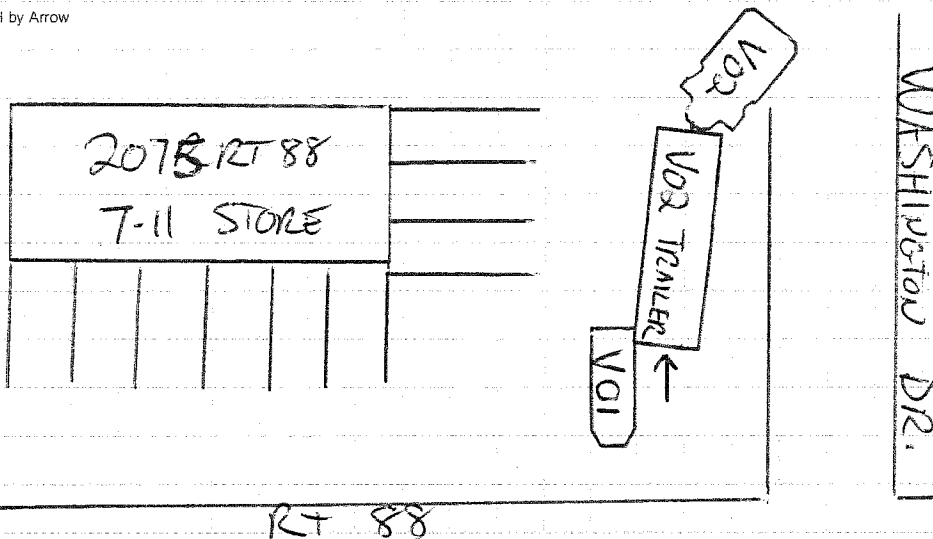

145. Crash Description/Narrative

IN THE PARKING LOT OF 2075 RT 88 7-11 STORE VEHICLE 01 MOVED FROM A PARKING SPACE TO ALLOW VEHICLE 02 BACK IN TO UNLOAD. WHILE VEHICLE 02 MADE A TURN TO THE RIGHT, THE TRAILER SWUNG TO THE LEFT STRIKING VEHICLE 01.

DRIVER OF VEHICLE 01 STATED SHE MOVED FROM A SIDE PARKING SPACE TO ALLOW ROOM FOR VEHICLE 02 TO BACK IN AND UNLOAD. VEHICLE 01 MOVED FACING NORTH TOWARDS RT 88 WHEN VEHICLE 02 PULLED AWAY IN THE OPPOSITE DIRECTION AND THE TRAILER PORTION SWUNG INTO THE REAR OF VEHICLE 01.

DRIVER OF VEHICLE 02 STATED VEHICLE 01 MOVED OUT OF A SPACE AND HE WAS UNAWARE IT HAD STOPPED VERY CLOSE TO HIS RIGHT REAR. VEHICLE 02 MOVED TO THE RIGHT & THE TRAILER SWUNG TO THE LEFT STRIKING VEHICLE 01. *ACE AMERICAN INS. DALLAS TX
