145. Crash Description/Narrative

Vehicle 1 struck the rear of vehicle 2 on Jack Martin Boulevard near the intersection of Falkenberg Road.

Driver 1 stated he was traveling north when vehicle 2 turned in front of him causing him to slam on his brakes and attempt to avoid the collision by driving onto the shoulder of the roadway. Driver 1 was unable to avoid the collision and his front driver side struck the rear passenger side of vehicle 2.

Driver 2 stated she turned onto Jack Martin Boulevard from Falkenberg Road when her vehicle was struck in the rear by vehicle 1. Driver 2 stated she observed Vehicle 1 traveling quickly prior to turning onto the roadway.

Based on my investigation I found Driver 2 to be at fault for failing to yield the right of way to traffic. Driver 2 was issued a summons for Careless Driving as well as a summons for operating a motor vehicle without a license. The registered owner was also issued a summons in the mail for allowing an unlicensed driver to operate a motor vehicle (E21-007905).

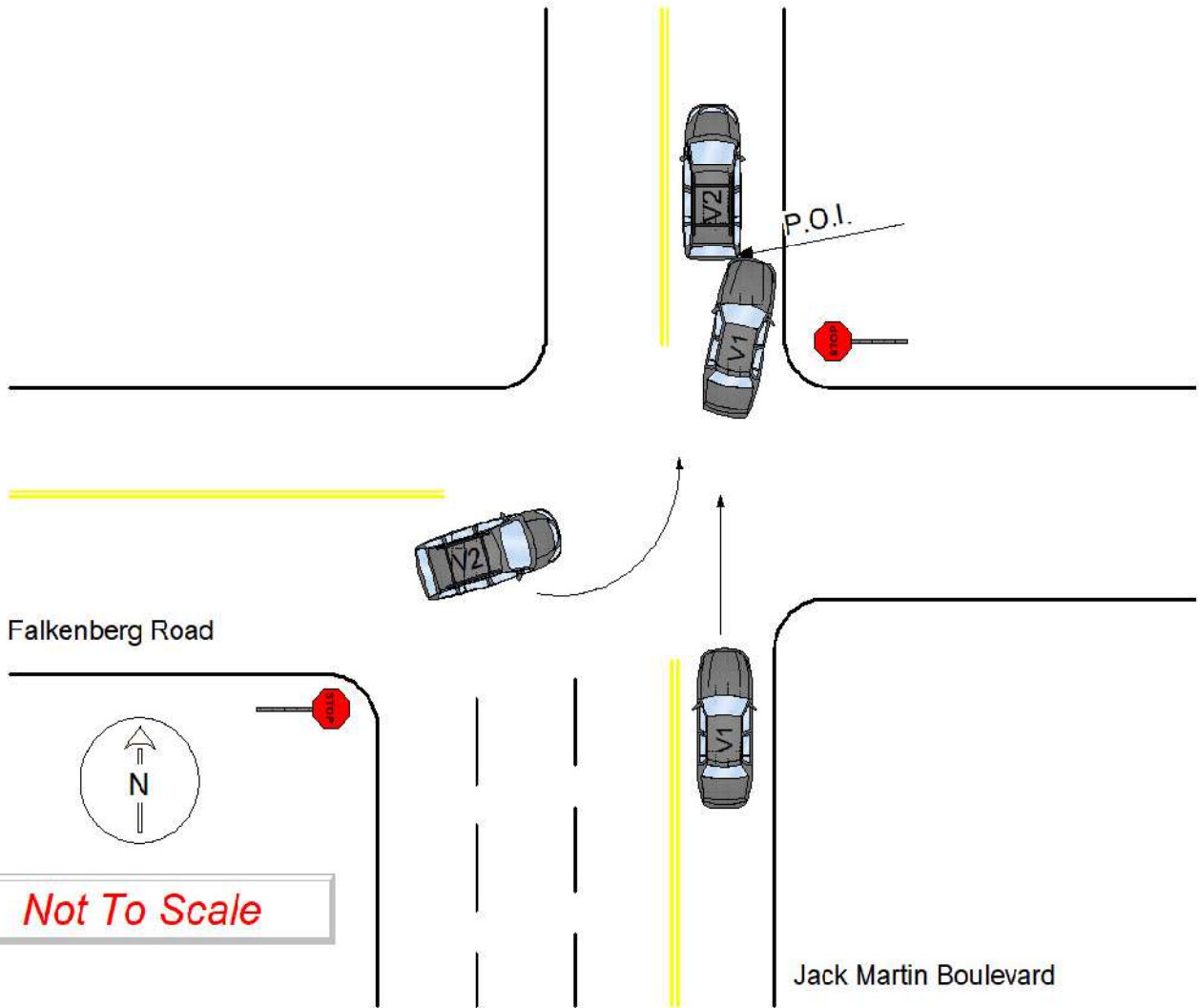
