145. Crash Description/Narrative

Vehicle 1 was exiting the Speedway gas station located at 1672 Route 88, onto Route 88 westbound. Vehicle 2 was traveling straight ahead on Route 88 westbound approaching the gas station.

The driver of Vehicle 1 stated that as she emerged from the driveway of the gas station, she looked for oncoming traffic, but did not see Vehicle 2 approaching. As Vehicle 1 exited the driveway to the gas station, it collided with Vehicle 2 in the roadway.

No injuries were reported at the scene. Cosmetic damage to both vehicles, which remained operable. No motor vehicle summonses were issued and both vehicles were driven from the scene.

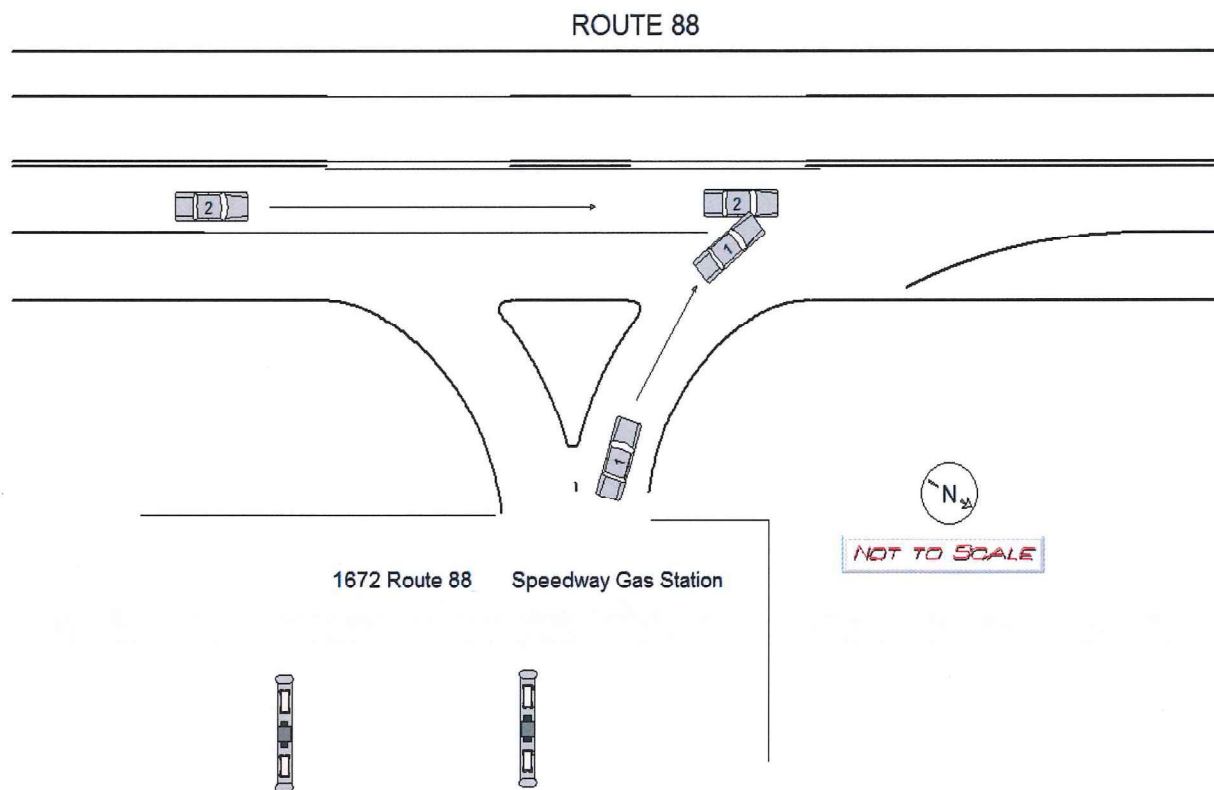
