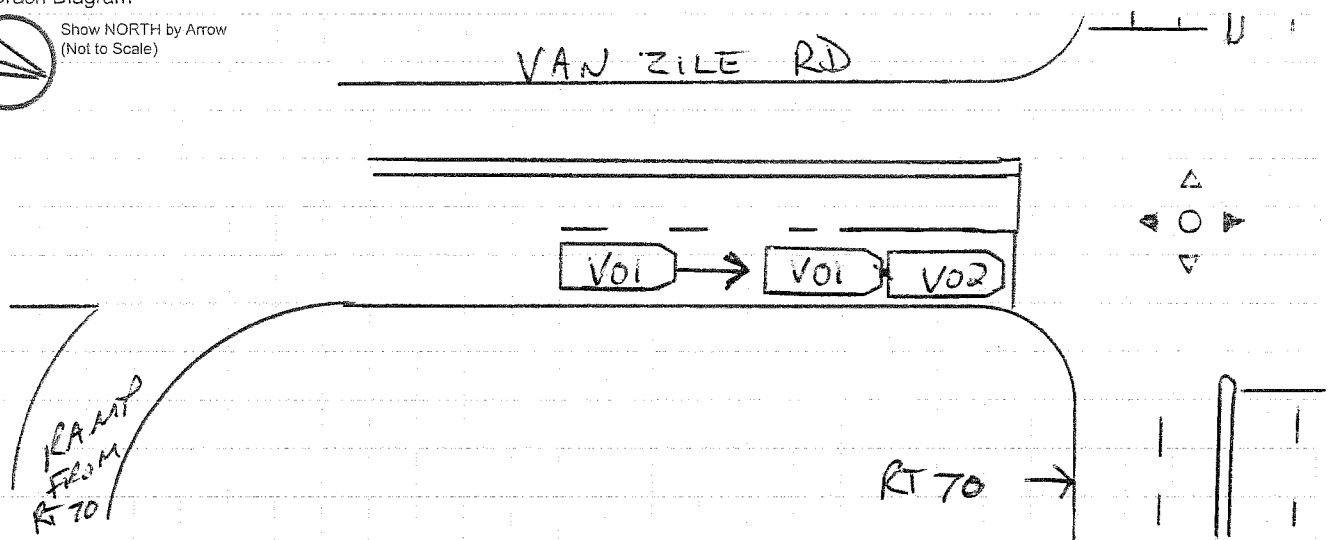

145. Crash Description/Narrative

ON VAN ZILE RD. VEHICLE 01 WAS TRAVELING NORTH WHEN STRUCK VEHICLE 02 STOPPED AT THE INTERSECTION OF RT 70. VEHICLE 01 STRUCK VEHICLE 02 IN THE REAR.

DRIVER OF VEHICLE 01 STATED HE HAD JUST CAME OFF THE RAMP FROM RT 70 EAST ONTO VAN ZILE RD. AND WHILE SLOWING FOR THE RED SIGNAL BUMPED THE REAR OF VEHICLE 02 THAT WAS DIRECTLY IN FRONT OF HIM IN THE RIGHT LANE.

DRIVER OF VEHICLE 02 STATED HE WAS STOPPED ON VAN ZILE RD. NORTH IN THE RIGHT LANE WAITING FOR THE RED SIGNAL WHEN VEHICLE 01 STRUCK HIM FROM BEHIND LIGHTLY AT FIRST THEN A LITTLE HARDER THE SECOND TIME.

DRIVER OF VEHICLE 01 WAS ISSUED A SUMMONS FOR 39.4-77.
